



**Agenda Action Form Overview**

The BOCC is requested to authorize the County Manager to execute a contract with Boundtree Medical in the amount of \$375,000.00 for the purchase of OES- Emergency Medical Services Medical Supplies. Funding for the contract is in the current FY OES- Emergency Medical Services budget.

**Background/Justification**

The Board is requested to authorize the County Manager to sign a contract with Boundtree Medical in the amount of \$375,000.00 for the purchase Office of Emergency Services Emergency Medical Services (OES-EMS) medical supplies. OES-EMS will utilize existing operational budget funds of \$375,000.00.

Historically, Durham County OES- Emergency Medical Services has purchased medical supplies through various vendors with no formal bid process having been completed. Due to the lack of formal bid process, OES- Emergency Medical Services has not had a contract with any medical supply companies which resulted in varying prices throughout the year.

To ensure continued improvement in efficiency and fiscal responsibility with medical supply purchasing, a formal bid process was conducted with multiple sections available for vendors to bid. All OES- Emergency Medical Services medical supplies were grouped into 7 sections and awards are based on vendors who provided the best value in each section. A backup vendor was selected for each section which offered the next best value for each section. This was done in the event of supply shortages and backorders to allow EMS to purchase medical supplies from a secondary vendor. Attachment 1, Medical Supply Bid Spec Worksheet is attached with details of all medical supplies included in each section. Section 1 – Airway Management, Section 2 – Monitor Supplies, Section 3 – CPAP and BVM, Section 4 – EZ IO, Section 5 – IV Supplies, Section 6 – Miscellaneous supplies, Section 7 – Trauma Supplies.

Boundtree Medical was the vendor that provided the best value to the County for bid sections 1 – Airway Management, 5 – IV Supplies, 6 – Miscellaneous Supplies, and 7 – Trauma Supplies with backup for section 2 – Monitor Supplies and Section 3 – CPAP and BVM. All bid documents are included in this action item.

**Policy Impact**

Office of Emergency Services – Emergency Medical Services is bringing a new issue to the Board of County Commissioners requesting the BOCC to authorize the County Manager to execute a contract of \$375,000.00 of existing FY24 operating funds to purchase OES-EMS medical supplies from Boundtree Medical
