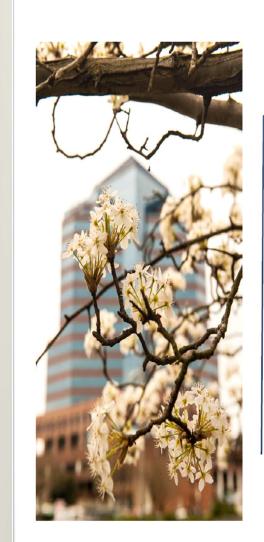

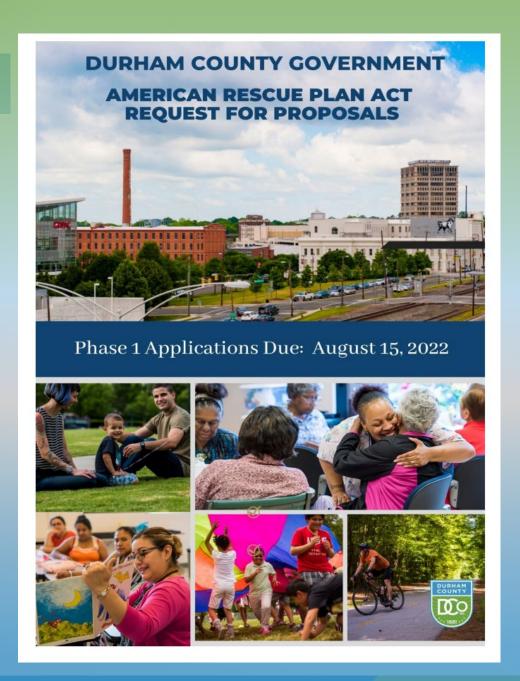

Key Dates – Recap

DECEMBER 31, 2024: Funds must be *incurred* and obligated

DECEMBER 31, 2026: Funds must be *expended* to cover obligations and all work must be completed

Guiding Principles Highlights Established in June 2021

- Prioritization given to funding priorities that support the Board's strategic and capital plans and other assessments endorsed by the BOCC.
- Leverage ARPA funds from federal, state and local community to optimize overall allocation.
- Prioritization given to funding that addresses equity including health disparities, closing the achievement gap, infrastructure support to unincorporated areas and funding to support minority-owned businesses.
- Evaluate infrastructure needed to address compliance increased workloads resultant from COVID-19 in the human services, public safety, and administrative operations.
- Establish framework for community discussions and input. Coordinate discussions with community
 partners when possible. Communications should include accommodation for non-English speaking and
 hard of hearing residents if needed to the extent possible in these sessions.
- County expenses that can be reimbursed through FEMA should be limited on ARPA dollars.
- Identify strategic one-time projects and/or a sustainability strategy for initiatives that require funding beyond one year.
- Establish rubric to evaluate and rank projects to ensure optimal and highest use of funds are achieved.

FREQUENTLY ASKED QUESTIONS (FAQS)



- What if I already applied for ARPA funding through the City of Durham's process?
 Applications for ARPA funding that were submitted through the City of Durham's
 process were shared with County Commissioners. However, the County's process is
 separate from the City's process and applicants will need to reapply through the
 County's RFP process to be eligible for ARPA funding from the County.
- 2. What if my proposal does not align with one of the Durham County's RFP categories? Durham County is taking a targeted approach to ARPA spending. The first phase of RFPs is limited to the following categories:
 - o Capacity Building and Technical Assistance for Child Care
 - o Expanding Access to Affordable Child Care
 - o Improving Child and Family Social Emotional and Mental Health Ages 0-12
 - o Improving Youth and Family Social Emotional and Mental Health Ages 13-24
 - o Youth Enrichment Activities
 - o Maternal Health Support
- Crime Intervention

Future RFPs will focus on Affordable Housing and Homelessness, Behavioral Health and Health Equity, Workforce and Economic Development, Food Security, and other priority areas. For more information about Durham's RFP process, please visit our website.

- 3. Do applicants need to have 501(c)3 status to be eligible for funding?

 Registered nonprofits with 501(c)3 status and government entities are eligible to apply for ARPA funding.
- 4. Do I need a fiscal agent/sponsorship?

To be eligible for funding, nonprofit organizations must have been registered for at least 2 years, meet the revenue thresholds within the RFP, and supply financial statements. If you do not meet these requirements, you may partner with a fiscal agent. Fiscal sponsors must agree to support the organization applying with administration, compliance, and reporting.

5. Are organizations required to undergo a risk assessment? If applicants are selected as finalists, they will be asked to complete the County's risk assessment in compliance with US Treasury guidelines. A draft copy of the Risk Assessment form that will be completed by Durban County staff is attached. County.

Assessment form that will be completed by Durham County staff is attached. County staff will coordinate with grant applicant finalist to complete the form.

6. Do organizations have to supply an audit?

Audits are preferred, but not required. Part of the risk assessment will ask organizations to supply an audit completed by a financial auditor if funded with ARPA dollars.

Rubric Questions and Evaluation Application

- Eligibility Does the proposed project clearly meet Treasury's eligibility guidelines? An updated list
 of eligible expenditure categories can be found in U.S. Treasury's <u>Compliance and Reporting</u>
 Guidance (page 42-46) completed in risk assessment
- 2. Compliance Does the proposed project clearly meet Durham County's Uniform Grant Guidelines? completed in risk assessment
- 3. Strategic Alignment Does the proposed project align with Durham's existing strategic goals?
- 4. Complexity How complex would it be to implement this solution? How long will it take to implement the proposed project? Is the proposed project an expansion of an existing initiative or a new initiative?
- 5. Community Benefit What percentage of Durham County residents do you expect to benefit from the proposed project?
- 6. Collaboration What stakeholders are named in the application? Is there cross-sector representation? Are these stakeholders already involved or does the application propose new partnerships?
- 7. Equity Will the proposed project reduce disparities/discrimination; if so how? Is there data and evidence that shows this solution will address historical inequities? Which neighborhoods and communities would benefit most from this project? Does the application explicitly state how it will deliver, measure, and report equitable outcomes?
- 8. Evidence of Sustainability Will the proposed project require funding beyond the ARPA grant period? Does the application identify additional funding sources to sustain the work past the conclusion of ARPA funding? If another source is identified to support the project beyond ARPA funds, how will the new source cover the expense? Has an agreement been signed to support the projected funds and have funds been set-aside for the future allocation? Do historical fiscal patterns align with projected revenue trends?
- 9. Environmental Sustainability Will the proposed project have a positive, negative, or neutral environmental impact?

10. Performance Evaluation – How will impact be documented and evaluated? Are there clear metrics proposed? How will they be monitored and reported.

After each group member has reviewed their applications individually, the group will meet to discuss their applications, evaluations, and any subsequent questions they may have for each application. The purpose of this meeting is NOT to come to a consensus on rubric scores, but discussion to answer any questions that may have arisen during the individual review process.

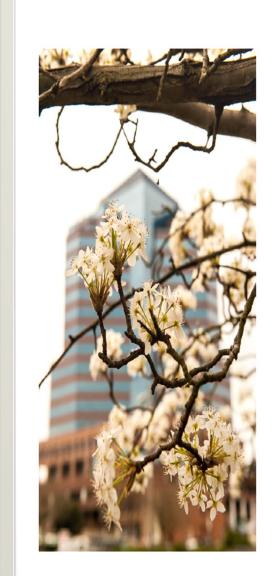
After the group meeting, group members will be able to make any changes or update their evaluation based on the group discussion. Once evaluations are completed, individual review members will upload their ARPA Review Excel Document to the Review Submissions folder within the ARPA Durham County Proposals One Drive.

Individual submissions will be totaled and averaged to determine the average score of the group for each application. The average score is used to help eliminate any biases that may exist in individual applications.



ARPA Proposals Evaluation Process

- Applications were reviewed by Durham County staff including internal and external subject matter experts. Five groups evaluated 75 nonprofit applications, totaling over \$20.2 million in requests.
- A scoring system considered the approaches on how funding would be used including, organizational capacity, project complexity, equity, fiscal management capacity and project sustainability after the funding was gone.
- Contracts are scheduled to begin in January 2023 with an end date of with a December 31, 2024
- The County will bolster infrastructure to support nonprofit entities to help ensure successful project completion and adherence to fiscal controls and reporting requirements.

RFP Category 1: Capacity Building and Technical Assistance for Child Care

The Request for Proposals sought technical assistance and capacity building services to licensed childcare sites and informal childcare providers seeking licensure.

- The focus of these proposals should be on helping childcare sites strengthen their business practices and recover from the financial losses of the pandemic, providing financial assistance to sites to help them purchase materials and support their staff, and/or providing support and training to informal childcare providers interested in establishing licensed family childcare homes.
- Proposals that supported family childcare homes, sites that provide infant/toddler care, and/or sites that care for children whose families work nontraditional hours will be prioritized.

RFP Category 2: Expanding Access to Affordable Child Care

The Request for Proposal sought providers that could expand access to affordable care for children 0-5 through financial assistance or scholarship funding.

- Proposals had to include support for families seeking infant/toddler care, families looking for work, and families whose income is too high to qualify for childcare subsidies but too low to afford market-rate care.
- Applicants must be current providers of childcare-focused financial assistance or scholarship dollars; partnerships with other groups were welcomed.

- Applicants must be current providers of culturally-affirming, trauma-informed social emotional and mental health supports; partnerships with other groups are welcome.

RFP Category 5: Youth Enrichment and Recreational Activities

The RFP sought proposals that enhanced academic opportunities and general well-being for youth in Durham. Proposals should expand access and remove barriers to youth enrichment programs like afterschool and summer programming. Proposals that focus on supporting the social, emotional, and academic needs of underserved students and students with disabilities will be prioritized.

The potential grants may also strengthen current programming or expand a new program offering. Funds can support educational, art, recreational and/or sports activities.

Organizations must be a registered non-profit and be willing to provide free or affordable youth activities for children ages 0-18. Proposals may build in funding for evaluation.

Applicants must be current providers of youth enrichment programs; partnerships with other groups are welcome.

RFP Category 6: Capacity Building for Culturally-Affirming Maternal Health Support

- County requested proposals that will scale culturally-affirming supports for pregnancy and postpartum periods. Nationally and here in Durham County, maternal and infant morbidity and mortality rates are disproportionately higher for these groups.
- Proposals sought that provided universal supports for maternal health, as well as proposals that address Black maternal health specifically. Supports can include financial assistance and the provision of essential family supplies, full spectrum doula care, lactation support, group or individual peer support and education, and resource navigation. Proposals may build in funding for evaluation.
- Applicants must be current providers of culturally-affirming maternal health supports, partnerships with other groups welcome

RFP Category 7: Crime Intervention Initiatives

- The RFP sought proposals that would contribute to community safety and combat crime through culturally affirming support systems.
- Funding could address conflict resolution, violence prevention, domestic violence intervention, health and wellness, and critical time interventions. Other examples include funding to address employment assistance programs and other vocational programs. Proposed projects should be targeted toward populations disproportionately impacted by the pandemic.
- Applicants must be current providers of community support programs;
 partnerships with other groups are welcome.
