## AAF Supplemental Document - New Youth Home Smart Saver Rebate from Duke Energy

# **Agenda Action Form Overview**

Recognition of a Rebate in the Amount of \$103,699.00 from the Duke Energy Smart Saver Program for the New Durham County Youth Home Project.

#### **Background/Justification**

This incentive program is a no-cost Duke Energy sponsored program to provide financial incentives for customers to design and build more energy efficient buildings by installing qualifying high efficiency equipment for lighting, mechanical, and glazing systems. The County benefits by receiving a \$103,699.00 check from Duke Energy in addition to a reduction in annual energy costs for the new Durham County Youth Home. The \$103,399.00 will support paying off the debt service fund related to the construction of the New Youth Home.

#### **Policy Impact**

This aligns with Goal 4 – Environmental Stewardship – through the improvement of the environmental performance of County buildings to reduce energy use and greenhouse gas emissions from the built environment.
