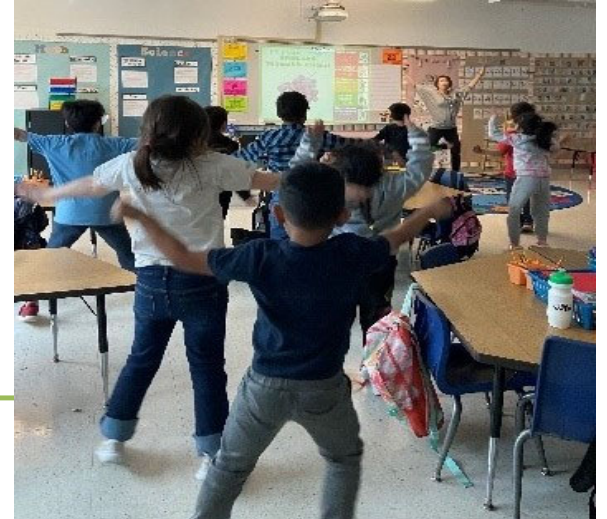

What will our community lose?



- DINE helps Durham by providing nutrition education that **meets families where they are**- in schools, clinics, food banks, and beyond
- DINE is more than just education; DINE **builds long-term self-efficacy**
- DINE **adds significant capacity to DPS**
- DINE **addresses food insecurity**



DINE: 25 Years of Community, Connection and Impact

DINE: 25 Years of Community, Connection and Impact

Current State of Funding

- H.R.1 eliminated SNAP-Ed funding effective October 1, 2025
- Loss: \$1M in FY26 funding for DINE Program

Impact

- 13 positions eliminated
 - 12 Registered Dietitians
 - 1 Processing Assistant
- Only 4 county-funded staff will remain to continue essential nutrition education & maintain community partnerships



Unless alternative funding is secured, the DINE program in its current form will not continue after September 30, 2025.



What will our community lose?

- **DINE in Early Childhood Education (ECE)**
 - Nutrition education in **19** preschools
 - Policy, system + environmental changes (PSE)
 - Farm to ECE, gardens, playground improvements
- **DINE in Community**
 - Programming at **19** community sites
 - Technical support + promotion for Triangle Double Bucks
 - \$277,370 in locally grown/produced food to residents
- **DINE in Elementary & Middle Schools**
 - Most of the nutrition education programming, which meets NC Healthful Living Standards, in **26** Schools
 - Policy, system and environmental changes (PSE)
 - School food pantries, gardens, playground improvements, Youth Food Policy Councils, menu improvements



Nutrition Education Programming includes:

- Cooking classes
- Exposure to new foods
- Gardening
- Making balanced meals
- Food safety
- Grocery shopping on a budget
- Reading nutrition labels
- Recipes





The Future of DINE



DINE hopes to continue programming + partnerships

- Four county-funded positions
 - Less than 25% of current team's reach
- DCoDPH funding
 - Internal budget reallocation: ~\$200,000
 - Expected lapsed salary within Nutrition Division: ~\$29,384
- Requesting County funding
 - Requesting DCo funding - at least through FY26
- Outside funding
 - Seeking grants and/or partnerships

DINE Reimagined at 55%



- Retain seven Registered Dietitian positions (6.48 FTE)
- Salary/Fringe = \$552,620
- Operational budget = \$32,400
- Total FY26 Cost: **\$585,020**
 - DCoDPH budget reallocation: \$200,000
 - County budget request: **\$385,020**



DINE Reimagined at 40%



- Retain five Registered Dietitian positions (4.48 FTE)
- Salary/Fringe = \$377,413
- Operational budget = \$22,400
- Total FY26 Cost: **\$399,813**
 - DCoDPH budget reallocation: \$200,000
 - County budget request: **\$199,813**
