**Approve Contract with Waste Industries LLC dba GFL Environmental for Solid Waste Collection and Hauling Services for Durham County Facilities for an amount not to exceed \$80,000.**

**Background/Justification**

The Board is requested to authorize the County Manager to execute a contract with Waste Industries LLC dba GFL Environmental for Solid Waste Collection and Hauling Services for Durham County Facilities for an amount not to exceed \$80,000 beginning July 1, 2025 through June 30, 2026.

This service will provide solid waste and recycling services for Durham County Government owned and/or operated facilities. Services to be provided include the collection, transportation, disposal, and processing of solid waste and recyclable material. In addition, the contractor will be required to provide dumpster, roll off container, and compactor rental, delivery, maintenance, and procurement.

The contract may be renewed for four (4) successive one (1) year periods under the same terms and conditions with the ability at the time of renewal to adjust the compensation payable to the Contractor based on the increase or decrease the Consumer Price Index (CPI), not to exceed three percent (3%). The compensation paid to GFL Environmental for FY 25-26 shall not exceed \$80,000. This contract will have no new fiscal impact for FY 25 as funds are part of the FY 2025-26 Budget.

This will be the eleventh year that GFL Environmental has provided this service.

**Policy Impact**

There is no change to current policy.

**Procurement Background**

On February 28, 2025, a Request for Proposal (RFP No. 25-036) for Solid Waste Collection and Hauling Services for Durham County Facilities was advertised to potential proposers. A Site Visit was conducted on March 11, 2025. Three (3) responses were received on April 10, 2025. The proposal review team determined that the Waste Industries LLC dba GFL Environmental's proposal offered the best value and met the proposal requirements.
