

## Agenda Action Form Overview

The Board is requested to authorize the County Manager to enter into an \$56,900.00 contract with Scottie's Building Services to provide exterior & interior window washing for six (6) County buildings. Admin II, HHS, Main Library, SW Library, South Library and North Regional Library.

### **Background/Justification**

Due to the number of County facilities in need of washing services an RFP was initiated. On December 5th, 2023 a Request for Proposals (RFP NO. 24-025) for Interior & Exterior Window Washing at Six Durham County Buildings was advertised on eBid and periodicals. A site visit of the facilities was conducted on December 20th, 2023 for interested bidders. Four (4) bidders responded on January, 2024. An evaluation committee made up of four (4) Durham County employees reviewed proposals and convened on April 2nd, 2024 for recommendation discussions. Scottie's Building Services was selected by the committee as the qualified vendor to provide exterior & interior window washing for six (6) County buildings.

### **Policy Impact**

This is consistent with Board of County Commissioners Building Maintenace policy provided in County buildings. The action does not require any BOCC policy changes.
