The Raleigh-Durham Airport Authority is in receipt of a new grant offer from the Federal Aviation Administration (FAA) for the Raleigh-Durham International Airport (RDU). Funds from the above-referenced grant will be used for costs to acquire four Zero Emission Vehicles and associated charging infrastructure.

You will note on the attached grant offer that the amount for Grant 3-37-0056-67-2024 is \$3,410,395.00, and it is comprised entirely of discretionary funds.

The Authority will take action to approve the grant in the very near future. As you are aware, the FAA also requires Durham County, along with Wake County and the cities of Durham and Raleigh, to accept grant offers made by the FAA under the Airport Improvement Program. Therefore, the Airport Authority is requesting that the County consider acceptance of the grant offer at its earliest opportunity.

Since the executed grant must be in the possession of the FAA no later than July 31, 2024, your attention to this urgent matter is greatly appreciated.
