The Board is requested to authorize the County Manager to amend the contract agreement with EPlus Technology in the amount of \$13,583.52 (for a new total of \$52,445.20) for IT Consulting Support for the County's Virtual Private Network (VPN), using current CIP project 4200DC141-21 IS&T Hardware & Service funds.

Background/Justification

The purpose of this contract amendment is to add additional hours for IT Consulting Support for the County's VPN appliance in support of the County's disaster recovery project. A virtual private network (VPN) appliance is a device that provides secure remote access to a private network using VPN technology. A VPN appliance is usually placed at the edge of the private network to allow authorized users to safely connect to internal servers from remote locations. This contract amendment will assist with supporting the County's VPN appliance configurations as part of the County's disaster recovery project to ensure secure remote access for County staff.

This contract will not have an impact on policy but will allow the IS&T Department to continue provide the services to support the daily and ongoing operations of the SAP software solution for the departments.
