

## SCOPE OF SERVICES FORM

This Scope of Services is an integral part of this contract between the **Sheriff of Durham County** ("Sheriff"), and **Motorola Solutions, Inc.** ("Contractor"), which contract is dated December 1, 2024. Contractor agrees to provide services and/or materials pursuant to the provisions set forth below.

This project will upgrade the current system that will go EOL at the end of calendar year 2024. It will upgrade the current database to a cloud version that will enable the Sheriff and designated personnel the ability to view video in real-time. The body-worn and in-car cameras will be placed into a service which will prevent the office from using old equipment and implement a system of automatic replacement for any broken or lost equipment at no extra cost.

Additional added features:

- 1) License Plate Reader capability
- 2) Auto synchronization between deputies within a determined radius
- 3) Field video upload
- 4) Automatic Vehicle Location to include ability to locate a deputy outside of their vehicle

A Motorola systems engineer will come onsite to move all data from the on-site system located at the Durham County Court House (510 S Dillard St., Durham, NC 27701) to the cloud system located in a Motorola data center. Motorola will also replace all outdated hardware that will remain at the Durham County Court House (510 S Dillard St., Durham, NC 27701) and the Durham County Detention Center (219 S Mangum St, Durham, NC 27701).
