Commissioner Burton moved, seconded by Commissioner Valentine to approve the agenda.

Monica Wallace, Clerk to the Board read the following announcements:

- 1. **DPS 2025 College Fair** Thinking about college? - 2. **Low-Income Homeowners Relief Program** Durham homeowners can now apply for Durham County's Low-Income Homeowners Relief Program, known as LIHR. This program is a joint effort from the Durham County Department of Social Services and the Durham County Tax Administration. This program exclusively serves homeowners who have lived in their homes for at least 5 years, have no current state tax subsidies for their property, and have incomes less than or equal to 80 percent of Average Median Income (AMI). - 4. Inaugural Durham County Fall Native Plant Sale The Durham Cooperative Extension and Durham Soil and Water Conservation District have teamed up to host the inaugural Durham County Fall Native Plant Sale on Thursday, September 25, from 4-6 p.m. at 721 Foster Street. - 6. **Deer Management at Duke Forest** The Office of the Duke Forest has announced that the 18th annual deer herd reduction program on the Duke Forest Teaching and Research Laboratory will begin on Monday, September 22 and end on Friday, December 12. During this time, the Durham, Korstian, and Blackwood Divisions will be CLOSED to public access and all recreation Monday through Friday (except Thanksgiving Day and the following Friday (Nov. 27-28). Saturdays and Sundays are OPEN normal hours of use, except for the seven-day-a-week New Hope Creek Restoration closure in the Korstian Division. Please note: Deer herd reduction will also take place in the Dailey Division of the Duke Forest from September 22 through January 1, 2026, and information, closed seven days per week. - 7. **Move-A-Bull City: An Open Streets Event** Save the Date! Commissioner Jacobs encouraged residents to complete the Durham-to-Roxboro Rail Trail Plan Survey to provide feedback on the project. She highlighted the launch of the Stagville Memorial Request for Proposals (RFP) and thanked Perri Manns, Deputy Director of Engineering and Environmental Services. Commissioner Jacobs shared insights from the National Association of Counties (NACo) Behavioral Health Peer Exchange in Henrico County, Virginia. She invited staff and residents to join the Board to participate in the Durham Pride Parade on Saturday, September 27th.

Commissioner Burton stated Terry David, Chief Executive Officer (CEO) of Families and Community Rising received the 2025 Corporate Leadership Award from the Triangle Business Journal. She shared she attended the CenterFest Festival and the Durham Arts Council celebrated CenterFest's 50th anniversary. Commissioner Burton stated she toured the Renegade and Maizon Apartments and highlighted the County's additional units of affordable housing.

Commissioner Valentine stated the 82nd National Association for the Advancement of Colored People (NAACP) North Carolina State Convention would be held in Durham on September 26, 2025.

25-0482 Proclamation – Fire Prevention Week

FIRE PREVENTION WEEK | 2025

- **WHEREAS**, Durham County is committed to ensuring the safety and well-being of all those living in Durham County and visiting; and
- **WHEREAS**, fire remains a serious public safety concern both locally and nationally, and the presence of lithium-ion batteries in many household devices introduces unique fire risks; and
- **WHEREAS,** most of the electronics used in homes daily including smartphones, tablets, laptops, power tools, e-bikes, e-scooters, and toys are powered by lithium-ion batteries, which if misused, damaged, or improperly charged, can overheat, start a fire, or explode; and
- WHEREAS, the National Fire Protection Association® (NFPA®) reports an increase in battery-related fires, underscoring the need for public education on the safe use of lithium-ion batteries; and
- **WHEREAS,** residents should follow three key calls to action: buy only listed products, charge batteries safely, and recycle them responsibly to prevent battery-related fires; and

- WHEREAS, lithium-ion batteries store a large amount of energy in a small space, and improper use such as overcharging, using off-brand chargers without safety certification, or exposing batteries to damage can result in fire or explosion; and
- **WHEREAS,** the proper disposal and recycling of lithium-ion batteries help prevent environmental hazards and reduce fire risks in the home and community; and
- **WHEREAS,** Durham County Office of Emergency Services' Fire Marshal team joined by first responders throughout the county are dedicated to reducing the occurrence of fires through prevention, safety education, and community outreach; and
- WHEREAS, the 2025 Fire Prevention Week™ theme, "Charge into Fire Safety™: Lithium- Ion Batteries in Your Home," serves to remind us of the importance of using, charging, and recycling lithium-ion batteries safely to reduce the risk of fires in homes and communities.

NOW, THEREFORE BE IT RESOLVED, I, Nida Allam, Chair and on behalf of the Durham Board of County Commissioners, do hereby proclaim the October 5 - 11, 2025, as

"FIRE PREVENTION WEEK"

CLOTHING INSECURITY AWARENESS DAY | 2025

- WHEREAS, September 15th is the inaugural National Clothing Insecurity Awareness Day, created by Note in the Pocket to bring national attention to an overlooked issue impacting millions of children in the United States; and
- WHEREAS, one out of nine people in the United States live below the poverty level lack access to adequate, appropriate clothing. While food and housing insecurity are widely recognized, clothing insecurity remains largely invisible despite being a basic human need; and
- **WHEREAS,** without proper clothing, individuals face barriers to education, employment, and even their own sense of dignity; and

- **WHEREAS,** in Durham, more than 50% of school aged children need support with their basic needs; and
- **WHEREAS,** Note in the Pocket began addressing clothing insecurity in 2005 with a mission is to provide quality clothing to homeless and impoverished children and families with dignity and love; and
- **WHEREAS,** Note in the Pocket expanded into Durham County in 2022, officially opening a location in Durham in January 2024; and
- WHEREAS, Note in the Pocket invites the Durham community to donate gently used clothing and shoes to local organizations, host a clothing drive, support clothing distribution centers through financial donations, and spread the word to help reduce stigma and inspire action.

- **WHEREAS,** faith leaders and grassroots organizations are reimagining care as collective, holistic, and grounded in justice at a time when safety nets like Medicaid and SNAP are under attack; and
- **WHEREAS,** Rooted in Wellness Day reminds us that public health is not just about medicine, but about community, policy, and the shared belief that everyone deserves to thrive; and

Consent Agenda

Chair Allam asked the Board if they requested to pull or comment on any items on the Consent Agenda.

Commissioner Jacobs requested to comment on Item 25-0497 and Chair Allam requested to comment on 25-0511.

- Item 25-0497 Commissioner Jacobs asked what would happen if the construction upfit cost exceeded the \$875,000 amount paid for by the landlord and inquired about the staffing for the Sheriff's Annex. David LaBarre, Director of Planning and Development, Sheriff's Office responded the construction upfit cost was discussed to ensure the project remained within the set budget. Claudia Hager, County Manager replied positions were realigned in the Sheriff's Office budget to support five full-time equivalent (FTE) positions for the Sheriff's Annex.
- Item 25-0511 Chair Allam asked how much of the funding was for repairs and how much was for new construction. Perri Manns, Deputy Director of Engineering and Environmental Services responded all the funding was for repairs. Chair Allam asked for the total amount the County funds spent on repairs. County Manager Hager replied she would provide the information to the Board. She added the leadership at Duke was committed to supporting Lincoln at a different level. Chair Allam asked about having discussions with Duke about paying for repairs and the growth of repairs. Mr. Manns responded most repairs were paid for with grants by the Federal Government or by Duke. Commissioner Jacobs stated the County needed to be reimbursed by

Duke for the repairs and she looked forward to discussions with Duke and Lincoln's leadership.

Hearing no additional comments, Chair Allam entertained a motion for approval.
