The Board is requested to approve a contract with BFPE INTERNATIONAL. in the amount of \$677,361.34 for Phase 3 of the county Lenel S2 security upgrade. The county security upgrade will include improvements and security upgrades to the Human Service Building, Main Library, East Library, and Southwest Library.

Background/Justification

Since September 2021, the County has been undertaking a comprehensive, multi-phase security upgrade and access control system conversion across multiple facilities. This initiative was launched in response to evolving security needs, outdated legacy systems, and the increasing demand for centralized, modernized access management.

Phase 1 focused on high-priority facilities and involved the installation of core infrastructure, including centralized access control software, initial hardware replacements, and security assessments. Phase 2 expanded the system to additional sites and addressed system standardization, user training, and integration with emergency protocols.

With the successful completion of the first two phases, the County is now positioned to initiate Phase 3, which will further extend and refine the security framework, correct blind spots at facilities and enhance coverage throughout Human Services building, Main Library, East Library and Southwest Library.

Policy Impact

This agenda is consistent with other security measures that the Durham County Security Manager has implemented over the past few months to ensure the safety of all. It is consistent with the policy of maintaining buildings and providing safe environments for public and employee use.
