

Agenda Action Form Overview

The Board is requested to approve the purchase of 5 ambulances through the SAVVIK Cooperative Purchasing Agreement and approve Budget Ordinance Amendment No. 22BCC00061 increasing the original budget of \$1,100,000 to \$1,312,255 for the purchase of five ambulances through appropriating \$131,000 of General Fund balance and the transfer of \$81,255 from the Office of Emergency Services fund center to the Non-Departmental Business Area to cover the expense.

The additional \$212,255 is requested beyond the \$1,100,000 approved funds to cover an increase in ambulance price due to inflation and supply chain shortages as well as the additional cost from the General Fund to purchase the "Stealth Power" anti-idle system.

Background/Justification

In FY21-22, the Board of County Commissioners approved funding to support the replacement of five ambulances as part of the county vehicle replacement policy in the amount of \$1,100,000. The SAVVIK Cooperative Agreement consortium will be used to purchase the Braun Ambulance through their authorized dealer Spartan Fire and Emergency Apparatus. Spartan submitted a quote January 5, 2022, in the amount of \$236,000 per ambulance which was expires January 31, 2022, however they have agreed to honor that quote for Durham County until the BOCC can take action in February. The quote from Spartan includes an additional \$26,451 per ambulance cost for the addition of the Stealth Power anti-idle system that improves vehicle performance, reduce idle and engine time, and reduce CO2 emissions. The cost for this anti-idle system was not included in the original approved budget however was later identified by OES as an addition which supports the Board of County Commissioners greenhouse gas emissions goal to reduce emissions by 50% from 2005 levels by 2030.

Fiscal Impact

\$1,100,00.00 was approved for the 5 ambulances in the FY 21/22 budget. \$131,000 is requested to be appropriated from the General Fund and the OES Department will transfer \$81,255 from their fund center to cover the expense of the ambulances and stealth power anti-idle system.
