## An Ordinance Amending the Durham Unified Development Ordinance and Zoning Atlas

## Be it Ordained by the Durham City Council:

**Section 1.** That the Durham Board of County Commissioners held a Public Hearing on Zoning Case Z2500025 and voted on November 24, 2025, to approve the Zoning Map Change described herein.

**Section 2.** That the Durham Zoning Atlas and Unified Development Ordinance are hereby amended by taking the following described property out of Science and Research Park, Science and Research Park-Core, Industrial Light, Industrial Park, Office and Institutional, Residential Suburban-20, Residential Rural, and Falls/Jordan Watershed Protection Overlay District B, and establishing the same as University and College-3 and Falls/Jordan Watershed Protection Overlay District B.
