### **Questions and Responses**

- Q1. What is the County's reason for going out to bid? Is there a mandatory rotation requirement?
- R1. The County is going out to bid for audit services as part of its commitment to transparency, fiscal responsibility, and good governance. While there is no mandatory audit firm rotation requirement in North Carolina under the Local Government Commission (LGC), the LGC does recommend periodic rotation or rebidding of audit contracts to ensure competitive pricing, promote fresh perspectives, and maintain auditor independence. This process allows the County to evaluate service quality and cost-effectiveness, ensuring that it continues to receive the best possible value for these essential services.
- Q2. Does the current audit firm use a MWBE firm and if so what percentage of the contract is the MWBE firm used?
- R2. The company is currently utilizing its own workforce, so the percentage is 0%
