



**Agenda Action Form Overview**

The Board is requested to authorize the County Manager to enter into an annual contract with Joy Cleaning Service LLC to provide janitorial services at the Durham County Health and Human Services Building, in the amount of \$314,400.00 for fiscal year 2025-2026, with the option to renew annually for additional 4 fiscal years.

**Background/Justification**

The Durham County Health and Human Services Building was previously being serviced by DeWhit Facility Services LLC under RFP #23-042. The bid cycle came due for renewal for the Health and Human Services Building. On April 1<sup>st</sup>, 2025, a Request for Proposals (RFP NO. 25-043) for Janitorial Services was advertised on the eBid system. A site visit of the new facility to receive janitorial services was conducted on April 14-17<sup>th</sup>, 2025 for interested bidders. Nineteen (19) bidders responded on May 8<sup>th</sup>, 2025. An evaluation committee made up of six (6) Durham County employees reviewed proposals and convened on June 18<sup>th</sup>, 2025, for recommendation discussions. Joy Cleaning Services was selected by the committee as the qualified vendor to provide Janitorial services to Durham County Health and Human Services Building.

**Policy Impact**

This is consistent with the Board of County Commissioners Janitorial service policy provided in County buildings. The action does not require any BOCC policy changes.
