Initial Response (July 6-7)

- Emergency Management (EM) proactively deployed to area of potential flooding to investigate
 - Flooding confirmed
 - **EM contacted** Durham Emergency Communications Center (**DECC**) to initiate response from Durham Fire (DFD) and Durham Police Departments (DPD)



- DFD assumed command of scene and went door-to-door
 - 81 water rescues over a 6-hour period
 - Performed initial damage assessments
- EM coordinated with American Red Cross (ARC) to determine needs
 - Housing assistance provided to 5 displaced families
- At 0155, the Eno crested at 25.63ft.; Incident stabilized by 0830





Initial Recovery (July 8-11)

- Focus on identifying needs and connecting community members to resources
 - Targeted human services canvassing
 - Mucking and clearing support from local VOADs
 - Non-congregate housing support for 15 family units
 - ARC case management support



- Joint City and County messaging
- Cooling center operations with Durham County Libraries
- Preliminary Damage Assessments (PDAs) and data collection for Individual Assistance (IA) and Public Assistance (PA)
- Continued monitoring and messaging for additional inclement weather





Ongoing Recovery (July 12-30)

- Coordination for Disaster Recovery Center
 - DCo Library North Regional Branch (Monday-Friday 10:00AM-5:00PM and Saturday 10:00AM-2:00PM) July 30-August 30
 - 6 individuals served on first day
- Conducted Joint Preliminary Damage Assessments (PDAs)
 - Individual Assistance (FEMA, NCEM, SBA, Durham EM)
 - Public Assistance (Durham EM, FEMA, NCEM and local stakeholders)
- State of Emergency
 - North Carolina issued a State of Emergency
 - Durham Couty and City of Durham issued retroactive local State of Emergency to enable residents and businesses to receive funding support





Longterm Recovery (July 31- present)

- Governor Stein signed a State Type I Disaster Declaration for Individual Assistance (IA)
 - Enabled NCEM to begin offering IA Grants
- NCEM requested a Presidential Declaration for Public Assistance
 - Local documentation from PDAs provided; continuing to await formal declaration
- Local coordination efforts continue to Support the Disaster Recovery Center at the Durham County Library - North Regional branch
 - County Communications developed a joint press release
 - City Communications developed a flyer to be distributed
 - Neighborhood Improvement Services conducted canvassing





Individual Assistance (IA)

There are six (6) IA categories, each providing different resources to disaster survivors:

- Crisis Counseling Assistance and Training Program
- Disaster Case Management
- Disaster Legal Services
- Disaster Unemployment Assistance
- Mass Care and Emergency Assistance
- Individuals and Households Program
