

Agenda Action Form Overview

Amend Contract with GFL Environmental for Curbside Recycling Services to Households in Unincorporated Durham County not to exceed \$503,798.40.

Background/Justification

Durham County has provided biweekly curbside recycling for unincorporated households since 1988. Unincorporated households (estimate 14,130) can recycle paper, cardboard, cans, and bottles at home. The original program began with 18-gallon bins. In FY 15, the County began the transition to 96-gallon roll carts.

This will be the third extension and fourth year of this contract. The compensation paid to GFL Environmental for FY 25-26 shall not exceed \$503,798.40.

Policy Impact

There is no impact on current policy.

Procurement Background

In FY 12-13, Waste Industries LLC was awarded the contract to provide this curbside recycling service (RFP No. 12-018). In FY 14-15, Durham County began the transition to 95-gallon roll carts. In FY 17-18, Waste Industries was selected again through RFP 17-032 to continue to provide the curbside recycling service. On November 15, 2018, Waste Industries, LLC merged with GFL Environmental. GFL Environmental is the current provider of curbside recycling collection.

On February 13, 2022, a Request for Proposal (RFP #22-021) for Durham County Curbside Recycling Collection Services was advertised to potential proposers. A Pre-Proposal Conference was conducted on February 22, 2022. One proposer, GFL Environmental responded on March 22, 2022. The proposal was reviewed by a selection committee and was determined to meet the requirements.
