EBERP is a new program to provide energy efficiency retrofits and limited home repair to low-to-moderate income households in Durham, Orange, and Granville Counties. The goal is to retrofit at least 230 homes in the three-county area to reduce energy use, greenhouse gas emissions, and energy burden. Neighborhood ambassadors will provide hands-on workshops to help households save more energy through behavior change.

This grant is funded through the Inflation Reduction Act as part of the Energy Efficiency and Conservation Block Grant program. It is a three (3) year, reimbursable grant with a period of performance beginning when the contract with the DOE is received and executed. The DOE is also providing a Community Energy Fellow for 12-18 months at no cost to the County to help with community outreach and program development. Durham County is providing \$166,147 as in-kind costshare made up of employee time spent on the project. Additional project partners include Orange County, Granville County, NC Sustainable Energy Association, Central Pines Regional Council, Piedmont Triad Regional Council, NC Clean Energy Fund, Enpira, and ShipShape.

This funding opportunity will support projects to increase access to Medicated Assisted Treatment (MAT) in jails and the capacity of local communities to collaborate across public safety, behavioral health, and public health to continue care in the community. The Sheriff's Office was selected as a Building Bridges site in February of 2020. These funds will expand the Sheriff's Medication Assisted Restorative and Treatment Program (SMART) at the Detention Center.

The request for qualifications (RFQ No.24-052) for the Architectural Design & Engineering Services for the Durham County Justice Services Department Transition House was advertised on June 9, 2024, and one response was received by the July 9, 2024 deadline. The response was reviewed by representatives from Engineering, Justice Services, and the County Manager's Office. RND Architects, PA, was selected as the appropriate firm for this project.

The project includes the development of design and construction documentation for renovating the County's Transition House located on Club Boulevard. The Transition House is a 1963-built single family home that has seen multiple retrofits throughout the years to comply with commercial building codes, however, it has reached the end of its effective lifespan. The structure is in need of major renovations to meet current

programmatic, accessibility, and energy requirements and goals. The renovation will improve efficiency, privacy and accessibility, and increase the Justice Service Department's ability to serve the Community through the addition of a small bedroom with a kitchenette and separate entrance for residents who need additional or longer-term support as they transition to fully independent living. The FY 2025 Durham Annual Transit Work Program "Work Program" is the annual budget for the Durham County Transit Plan and includes the projected revenues, expenditures, as well as a Multi-Year Capital Improvement Plan. It was approved by the Durham Board of County Commissioners ("BOCC") on April 8, 2024, and by the GoTriangle Board of Trustees ("GoTriangle") on June 17, 2024.

On April 21, 2023, GoTriangle notified the BOCC and other members of the Durham County leadership team of their decision to retain the Regional Transit Authority Vehicle Rental Tax ("Vehicle Rental Tax"), from the Durham, Orange, and Wake County Transit Work Programs effective July 21, 2023. This action reduced the Durham FY 2024 Annual Work Program Revenues by \$1,427,947. Following this action, the Vehicle Rental Tax was excluded as a revenue source during the development of the FY 2025 Work Program. The Durham County Transit Governance Interlocal Agreement states that "future allocations of the Vehicle Rental Tax after FY23 shall be subject to the sole discretion of the GoTriangle Board of Trustees' approval."

On August 7, 2024, GoTriangle approved a partial return of the Vehicle Rental Tax to the Durham, Orange, and Wake County Transit Work Program for Fiscal Year 2025. Upon receipt of the Vehicle Rental Tax Revenues, the Durham County Work Program revenues will increase by \$799,294. These revenues will be incorporated into the fund balance. To formally recognize receipt of these additional revenues, a Work Program revenue amendment must be submitted to the BOCC for approval.

For farms to be eligible for consideration, the County needs to have a signed commitment (real estate option) securing the County's and owner's intent to proceed if funding is approved. The real estate options give the County the right, but not the obligation, to purchase the easements. ALE funds would pay 50% of the approved appraised conservation easement values. The County's estimated total costs for both easements (including 50% of the easement value, survey, appraisals, and closing costs) should not exceed \$270,000. The County's open space and farmland capital project account has sufficient funds to pay the County's portion so no additional funding is needed for these two easements. If ALE funds are awarded and the projects continue, final budgets will be brought to the Board for approval prior to closing.

These schedule delays and difficulties with initial installation of the HVAC and other elements of the upfit have caused the delivery of the restaurant to fall well behind the schedule originally established in the Lease Agreement. This is now the 5th Amendment to the Lease. The Tenant has worked diligently to successfully solicit bids from qualified contractors, secure the necessary permits, and complete the work.

It is worth reiterating that the Tenant is an experienced restaurant operator that has opened several restaurant concepts throughout the Triangle region and elsewhere. The Tenant has expressed their commitment to completing this project and opening this new restaurant in Admin II as soon as they are able.

The Tenant anticipates opening for business in October, 2024. They are seeking an extension of the Rent Commencement Date to the earlier of 180 days after Tenant's opening for business, or May 1, 2024.

The Request for Qualifications (RFQ) for Construction Manager at Risk Services for the Durham County Sheriff's Training Facility was advertised in local newspapers on July 27, 2023. A pre-proposal conference was held on August 8, 2023, and three proposals were received on August 31, 2023. An evaluation committee comprised of representatives from the County Manager's Office, Durham County Sheriff's Office, General Services, and Engineering Department reviewed proposals, interviewed all three firms, and found CT Wilson Construction/Rankin III Grading as the most qualified for the project.

The Pre-Construction Services phase of the project is the first step in the Construction Manager at Risk process in which the contracting team will provide cost estimates, constructability reviews, schedule development and value analysis of the project design. This initial contract is necessary for the CM @ R to provide analysis of the schematic design and design development of the project. Funding for this service will be available in the Durham County Sheriff's Training Facility Capital Project account provided this associated CPA is approved.

This project will entail construction of a new 10,000 square feet training and

administrative building, fully renovated outdoor firing range facilities, and site improvements to include improved drainage, walkways, driveways, and parking at the existing Sheriff's Firing Range. Approval of Intent to Award Housing for New Hope a Grant under the American Rescue Plan Act (ARPA) Nonprofit Grant Program Phase 3 - Homeless Services Grant Program

Agenda Text:

The Board is requested to approve the selection of Housing for New Hope, Inc. as the recipient of the County's ARPA Nonprofit Grant Program Phase 3 - Homeless Services Grant Program award. The grant award will total up to \$2,000,000 with a period of performance ending September 30, 2026. The County Manager's Office will be working with Housing for New Hope during the next phase of the subgrant process to complete a risk assessment and finalize the Scope of Work and Program Budget for the grant award before bringing a finalized subgrant award agreement for Board approval.

In recognition of the significant health and economic impacts of the COVID-19 on the County's population of individuals experiencing homelessness, \$2,000,000 was included as part of the Board's strategic plan for administering the County's ARPA funding for the purposes of providing a grant to an organization to support the provision of daytime services for individuals experiencing homelessness in Durham County. On May 2, 2024, the County published a Request for Proposals (RFP) for the ARPA Homeless Services Grant Program to solicit applications for grant awards to expand daytime services for individuals experiencing homelessness within Durham County.

At the time of the closure of the solicitation on June 3, 2024, the County had received 4 eligible proposals that were subsequently evaluated and scored by a review panel using an approved evaluation rubric. Based on the panel's review, it was determined that the Housing for New Hope application was the highest scoring application submitted in response to the RFP. As such, Housing for New Hope is recommended for selection by the Board as a grant recipient for the ARPA Homeless Services Grant program.

Alignment with Strategic Plan: This item aligns with Goal 2, Healthy and Inclusive Community - Objective 1 (Increase healthy outcomes and quality of life for residents), Objective 2 (Increase equitable outcomes through County operations and services), and Objective 3 (Expand and provide services that support residents across their entire lifespands).

# Page Road Lift Station, Force Main and Gravity Main project (15min)

#### Agenda Text:

The Board is requested to conduct a Public Hearing to receive comments on the Utilities Division's Engineering Report/Environment Information Document (ER/EID) for the Chin Page Road Lift Station, Force Main and Gravity Main project.

A new Chin Page Road Lift Station and associated piping has been recommended to increase sewer capacity in the Northeast Creek basin, which consists of the majority of Research Triangle Park (RTP) and surrounding areas. The current sewer infrastructure in this basin does not have sufficient capacity for proposed development, re-development, and future flows anticipated from the recently adopted Durham City-County Comprehensive Plan.

The project entails construction of a 10.2 million gallon per day (MGD) lift station, approximately 1,000 feet of 30-inch gravity sewer influent to the lift station, 500 feet of 24-inch force main, and roughly 4,000 feet of 30-inch gravity mains.

The project is being funded in part by DWI via a Clean Water State Revolving Fund loan in the amount of \$19,298,025. The loan will be repaid over a twenty (20) year period at a maximum interest rate of 1.16%. Additionally, the Board approved appropriating \$1,875,250 of Sewer Utility Enterprise Fund Fund Balance for pre-construction services at \$1,400,000, plus \$385,961 for the Clean Water State Revolving Fund loan fee, plus \$89,289 for Contingency.

Durham County issued a call for public comments from August 20, 2024, to September 9, 2024. Durham County Utilities and CDM-Smith will review all comments received through the public comment period and through the public hearing to prepare them for DWI analysis.
