The Raleigh-Durham Airport Authority is in receipt of a new grant offer from the Federal Aviation Administration (FAA) for a project at the Raleigh-Durham International Airport (RDU). The Raleigh-Durham Airport Authority Board of Directors approved acceptance of the grant offer at its July 19, 2018 meeting.

As you are aware, the FAA also requires Durham County, along with Wake County and the cities of Durham and Raleigh, to accept grant offers made by the FAA under the Airport Improvement Program.
