The N.C. 98 Corridor Study is 27-miles long, extending from U.S. 70 in Durham County through Wake County to U.S. 401 in Franklin County, North Carolina. This project evaluated safety and congestion, planned and existing roads, bicycle/pedestrian facilities and transit use of N.C. 98 to create short- and long-term recommendations to improve multimodal travel in the corridor. # 18-0905 Proclamation for National Recovery Month - September 2018

# 18-0915 Settlement of 2017 Property Taxes and the Charge of 2018 Property Taxes to the Tax Collector

Agenda Text:

The Board is requested to approve the 2017 Tax Settlement and Charge the Tax Collector with the 2018 taxes.

As required by General Statues (G.S.) 105-373, the Tax Administrator is herewith submitting the settlement report of 2017 property taxes.

G.S. 105-373 (h) further authorizes the Board of County Commissioners to relieve the Tax Collector of the charges of taxes on classified motor vehicles that are one year or more past due.

Additionally, the General Statutes bar use of any remedies for collection enforcement that is not instituted within 10 years of said taxes becoming due.

Furthermore, pursuant to G.S. 105-321 (b), the Board of County Commissioners charges the Tax Collector with the 2018 Property Tax Receipts.

The Tax Administrator requests authorization to relieve charges of taxes that are beyond the statute of limitations of 10 years and those vehicles that are more than two (2) years past due. This request is consistent with last year's settlement, which was authorized by the Board.

Alignment With Strategic Plan: This item aligns with Goal 5: Accountable, Efficient and Visionary Government. Compliance with North Carolina General Statutes ensures we are accountable to our citizens. The actions of the tax department impact all strategic goals due to the revenues needed.

The Board is requested to approve Tax Administration Office request for Employment of Experts as indicated under North Carolina General Statutes 105-299 for contracted services by Tanner Valuation Group through fiscal year 2019 for \$124,950.

Tanner Valuation Group provides residential and commercial appraisal assistance, appraisal administrative assistance, data quality assurance assistance and data entry assistance for County General Reappraisals. The contract with Tanner Valuation Group LLC will ensure continued appraisal assistance to support the upcoming 2019 County Wide Revaluation. Funding for this service has been requested and approved in the 2018-2019 budget. This vendor analyzes data and insures the quality and equity of the reappraisal. Working with this vendor helps to ensure the revaluation will be completed in a timely manner.

# 18-0987 Approval of Letter of Support for Durham-Orange Light Rail Transit Project

Agenda Text:

The Board is requested to approve the attached letter of support for the Durham-Orange Light Rail Transit Project.

Durham and Orange Counties have both had to review their funding strategies for the Durham-Orange Light Rail Transit Project as a result of reductions in the State of North Carolina's funding commitment to the project. Durham's Article 43 sales tax devoted to transit continues to perform very well and can support the additional debt necessary to make up for the reduction in state funding without Durham having to implement any additional strategies for raising revenue.

The attached letter will be part of Durham's communication with the Federal Transportation Administration, assuring them of continued and sufficient local support for this project. As noted in the letter, any local plans that need to be revised as a result of these changes will be revised accordingly.

# First Public Hearing For County Community Development Block Grant (CDBG) Neighborhood Revitalization Grant Application

#### Agenda Text:

The Board is requested to hold a public hearing for the purpose of receiving public input on the proposed application for CDBG Neighborhood Revitalization funds from the North Carolina Department of Commerce.

Durham County is an eligible applicant for up to \$750,000 from the North Carolina Department of Commerce as part of their CDBG Neighborhood Revitalization program. Since 2013, all funds from this state program had been re-allocated to water infrastructure projects (such as our Rougemont Water System), but Commerce has been convinced to put some of it back into neighborhood revitalization. The program allows a broad range of uses to be funded. The funds that Durham County would be eligible for can only be used outside of the City limits.

The County, working with the Triangle J Council of Governments (TJCOG) and local housing non-profits, is applying for \$750,000 / 3-year neighborhood revitalization grant. Two public hearings to receive input on the application are required. This is the first of the two public hearings.

The proposed plan is to focus on two main allowable uses of funds for this grant program: home repair as well as acquisition / rehabilitation of affordable housing (with the intend of adding them to the permanently affordable housing stock in Durham).

<u>Alignment With Strategic Plan:</u> More and better affordable housing options, including facilitating the repair of existing low-cost housing, improves outcomes across all domains of our Durham County Strategic Plan.
