2. **Durham County, State Officials Announce the Expansion of AveXis, Inc., in RTP** - Durham County Government played a pivotal role in an official announcement at the North Carolina Biotechnology Center on Monday, February 18, 2019, where gene therapy company AveXis, Inc., and the North Carolina Department of Commerce announced a doubling of the expansion of AveXis' manufacturing center in Durham County. The \$60 -million expansion will bring an additional 200 jobs that offer a spectrum of employment opportunities that exceed the County's average pay. AveXis, which develops treatments for rare and life-threatening neurological diseases, previously announced it would expand in May 2018 and create 200 jobs with a \$55-million investment at its facility located inside Research Triangle Park.

19-0099**Recognition of the Recent Graduating Cohort of Bull City YouthBuild****Agenda Text:**

The Board is requested to recognize and congratulate the recent graduating cohort of Bull City YouthBuild.

YouthBuild is a drop-out recovery program designed to give youth ages 16-24 the opportunity to earn their high school equivalency and become highly employable through hands-on construction skills experience. The mission of Bull City YouthBuild is to cultivate community leaders by providing inclusive and creative pathways for

young adults to build the educational and job skills needed to be a positive force for change. Our students with the partnership with NC State University wrote a book entitled "Strong and Unbroken." It's comprised of poems, stories, reflections and more. Bull City YouthBuild's Cohort 2 Students averaged 650 hours of instruction per student. The Average attendance rate of 80%, 26 students received OSHA certificates, 93% of students made at least one Educational Functioning Level gain, 81% of students made at least two Educational Functioning Level gains and 21 graduated the program.

19-0092**Contract Amendment for Velasquez Digital Media Communications****Agenda Text:**

The Board is requested to approve additional funding to support taping and broadcasting of County Commissioners Meetings and the added service of producing the “In Touch with Durham County” TV show through the end of the fiscal year.

The Board is asked to authorize the County Manager to execute an amendment to the current contract of \$30,000 with Velasquez Digital Media Communications in the amount of 25,000. The total is not to exceed \$55,000.

Velasquez is the company that provides broadcast services for Durham County to include videotaping and broadcasting BOCC meetings, editing the County’s TV Show and other special video services as needed. This request is being generated due to a funding shortage that emerged related to the change of taping locations and original vendor.

With the move into Admin II and the availability of a new studio, a decision was made to transition filming of “In Touch” to Velasquez Digital Media. The company received specialized initial training to make the studio operational. The new task of shooting the show was added to the Velasquez existing contract to bridge the gap created when the previous contractor was unable to transition into the new location. Velasquez agreed to provide the services needed to produce the show between October and the end of the fiscal year.

This request will not require any new money because there are sufficient funds in the Public Information Broadcasting budget line item to support the adjustment.
