Disabled Veteran Property Tax Relief Deadline is June 1st - Veterans who are totally and permanently disabled during their service, or their surviving spouses, may qualify for a \$45,000 reduction in their property tax assessment.

Adoption of Resolution related to Authorization of a Not to Exceed \$70,000,000 General Obligation (GO) Bond, Series 2019

Agenda Text:

The Board is requested to adopt the attached resolution (the "Resolution") which authorizes the issuance of a not to exceed \$70,000,000 General Obligation Bond (the "Bond"), issued pursuant to bond orders for community college, library, museum and school purposes adopted by the Board on August 8, 2016 and made effective on the affirmative vote of a majority of the qualified voters of the County as a referendum held on November 8, 2016. The Bond, which will be purchased by PNC Bank, National Association (the "Purchaser"), is short-term in nature and expected to be

taken out with long-term general obligation bonds before the end of the fiscal year ending June 30, 2022. In addition to authorizing the issuance of the Bond, the Resolution also authorizes the County to enter into the Bond Purchase and Advance Agreement to be dated as of June 12, 2019 among the County, the Purchaser and the Local Government Commission of North Carolina (the "LGC"), a copy of which is attached to the Resolution for the Board's information, pursuant to which the LGC will sell the Bond to the Purchaser in accordance with the Local Government Bond Act.

Administrative Interpretation of Falls/Jordan (F/J-A and F/J-B) Watershed Protection Overlay Districts

Agenda Text:

The Planning Department recommends that the Board of Commissioners approve the request to revise the F/J-A and F/J-B watershed protection overly boundary line for the property located at 739 Baptist Road as shown on the survey (Attachment 4) and further depicted on the context map (Attachment 1).

Summary: Jacob Anderson has requested an administrative interpretation of the watershed overlay boundary for property located at 739 Baptist Road. Mr. Anderson specifically requests that the current boundary between the F/J-A and F/J-B be relocated as reflected on the attached survey (Attachment 4). The request includes a signed and sealed survey which shows the location of the normal pool for Falls Reservoir.

The North Carolina Administrative Code, in Rule 15A NCAC 02B.0104(o), requires that the EMC approve all expansions and deletions to Protected Area and Critical Area boundaries prior to adoption by the local government. The approval authority was delegated from EMC to the Division of Water Quality (DWQ) and then later transferred to the DEMLR. The DEMLR has reviewed and approved the proposed amendment to the F/J-A and F/J-B watershed protection overlay boundary (Attachment 5).

- 2) Adopt an ordinance amending the Unified Development Ordinance by taking property out of the Commercial Neighborhood (CN), Residential Suburban-10 (RS-10), and Lake Michie/Little River District B Watershed Protection Overlay (M/LR-B) zoning districts and establishing the same as Commercial Neighborhood with a Text-Only Development Plan (CN(D)) and Lake Michie/Little River District B Watershed Protection Overlay (M/LR-B) zoning districts.

Summary: This is a request to change the zoning atlas for property located at 12907 and 12807 North Roxboro Road and 123 Bill Poole Road from Commercial Neighborhood (CN) and Residential Suburban-10 (RS-10) to Commercial Neighborhood with a Text-Only Development Plan (CN(D)). Staff determines that this request is consistent with the *Comprehensive Plan* and applicable policies and ordinances.

The Equalization and Review Board shall be exempt from these term limits.
