Due to delays related to the cyber-attack and Covid-19, this contract process was delayed, and funds were not encumbered. Additional funds are requested in order to complete the encumbering of the funds necessary to proceed with this project.

This project will be funded through the Register of Deeds Automation Enhancement and Preservation Fund, which by State Statute set aside funds annually from customer fees, to be used for computer or imaging technology and needs associated with preserving and storing public records in the Register of Deeds' office.

# Submission of Comments in the NC Utilities Commission Docket E-100 Sub 165 of Duke Energy's 2020 Integrated Resource Plan

Agenda Text:

The Board is requested to approve having the Chair of the Board of Commissioners or her designee sign on to the North Carolina local government group comments to Duke Energy's 2020 Integrated Resource Plan (Docket E-100, Sub 165) and directs staff to continue to work with other North Carolina local governments on this issue throughout the IRP process.

Every two years Duke Energy submits an integrated Resource Plan (IRP) to communicate strategies for delivering reliable electricity at the lowest cost across a 10-20year horizon. The IRP models potential pathways for Duke to provide affordable, reliable electricity and opportunities to accelerate renewable energy deployment, lower carbon fuels, and energy efficiency. There is a review process that includes opportunities for stakeholders to provide input into the plan. This review process is an opportunity for Durham County to join with other North Carolina communities to share our climate action goals and communicate how the IRP can best support them.

This is the first IRP that has been published since Durham County adopted a 100% clean, renewable energy goal in November 2018. Section 3 of that resolution commits the county to work with Duke Energy, the Public Utilities Commission, and others to aggressively increase renewable energy in the grid to help us meet our goals. Commenting on the IRP through this process is in line with that directive by taking advantage of an opportunity to advocate for bringing more renewable energy to our electricity grid. The County can also highlight the need for more support with local energy efficiency programs and electric vehicle infrastructure.

#### Agenda Text:

The Emergency Rental Assistance program makes available \$25 billion to assist households that are unable to pay rent and utilities due to the COVID-19 pandemic. The funds are provided directly to States, U.S. Territories, local governments, and Indian tribes to provide assistance to eligible households through existing or newly created rental assistance programs.

Durham County received \$1,244,759.40 from the program, and this action is requesting that these funds be added to the DSS budget.

Not less than 90 percent of awarded funds must be used for direct financial assistance, including rent, rental arrears, utilities and home energy costs, utilities and home energy costs arrears, and other expenses related to housing. Remaining funds are available for housing stability services, including case management and other services intended to keep households stably housed, and administrative costs.

These funds expire on December 31, 2021. The assistance listing number (CDFA number) assigned to the ERA program is 21.023.

# **21-0109** Request Refund of Payment of Excise Tax to Bagwell, Holt, Smith P.A.

Agenda Text:

The Board is requested to refund excise tax paid in error to Durham County to the Law Firm of Bagwell, Holt, Smith P.A. On October 14, 2020 a deed was electronically recorded in Durham County, with excise tax paid in the amount of \$1,150.00, which should have been filed in Orange County. Pursuant to N.C. General Statute, 105.228.37 Before a tax is refunded, the taxpayer must record a new instrument reflecting the correct amount of tax due. If no tax is due because an instrument was recorded in the wrong county, then the taxpayer must record a document stating that no tax was owed because the instrument being corrected was recorded in the wrong county. The taxpayer must include in the document the names of the grantors and grantees and the deed book and page number of the instrument being corrected.

When a taxpayer records a corrected instrument, the taxpayer must inform the register of deeds that the instrument being recorded is a correcting instrument. Increase for the Interlocal Agreement between the City of Durham and Durham County for the City to Provide Recycling Processing and Haul Services to Durham County for Target Recycling Materials

#### Agenda Text:

The Board is requested to authorize the County Manager to increase funding for the interlocal agreement with the City of Durham in the amount of \$140,000, for a total amount of \$350,000 for the City to provide recycling processing and hauling services to Durham County for target recycling materials.

When the Funds Reservation was set for FY21, it was not known how high the new rate would fluctuate, so the funds reservation was kept at the previous year's amount of \$210,000. Based on the information we have gathered during the first six months of this fiscal year, we have determined that we will need additional \$140,000 to continue processing recyclables for the remainder of FY21.

This request will not amend the interlocal agreement with the City of Durham. All the terms and tonnage fees shall remain unchanged as approved by the Board of County Commissioners on May 26, 2020.

Based on analysis of the first six months under a new variable fee structure, staff have determined that an additional \$140,000 will be needed for the current 2020-2021 fiscal year. Funding for this request will come from Solid Waste's contracted services fund.

providing solid waste services to unincorporated residents in Durham County which includes curbside recycling, litter control and abatement, and the management of residential convenience sites. # **21-0121** Board Approval - To Consider Allocating Economic Development Funds to Adverum

### Agenda Text:

The Board was requested to hold a public hearing at the February 8, 2021 Regular Session meeting to consider allocating a total of \$653,000 to Adverum. There was one public comment received during the 24hr public comment period which ended on February 9, 2021.

The Board was also requested to authorize the County Manager to enter into preliminary negotiations and execute an agreement with the Company. The Company, which specializes in Gene Therapy production, will locate in Durham County, creating 202 jobs and investing \$82.8 million.

Adverum Biotechnologies is a clinical-stage gene therapy company targeting unmet medical needs in serious ocular and rare diseases. The Redwood City, Calif.-based biotechnology company is developing its lead gene therapy candidate ADVM-022 in ongoing clinical trials for wet age-related macular degeneration (AMD) and diabetic macular edema (DME). ADVM-022 is administered as a potential one-time, intravitreal injection for the treatment of wet AMD and DME, ocular diseases that impact millions of patients worldwide.

With approval of the award, the Company has agreed to make reasonable efforts to

participate in several workforce partnerships that include engagements with Durham Public Schools Career and Technical Education, Durham Technical Community College and North Carolina Central's University. Please find additional project details including a full list of partnerships, terms and project attributes in the briefing sheet attached to the agenda item.

Adverum Biotechnologies' new presence in North Carolina will be facilitated, in part, by a Job Development Investment Grant (JDIG) approved by the state's Economic Investment Committee on January 7th. Over the 12-year life of the grant, the project is estimated to grow the state's economy by nearly \$1.36 billion. Payments for all JDIG and local awards only occur following performance verification that the company has met its incremental job creation and investment targets. The anticipated revenue that the project will generate is at least twice the size of the proposed local award and payment to the Company occurs only after the annual verification of jobs and investment criteria starting in 2022.

Staff is recommending that the County provide \$653,000 in Economic Development Investment funds to Adverum subject to performance goals being met by the Company related to timing and amount of investment, employment creation and maintenance of the created jobs as well as partnership engagement criteria.

This public hearing has been advertised as required by law.

#### Agenda Text:

The Board is requested to approve Capital Project Amendment No.21CPA000024 appropriating \$1,350,000 of PAYGO Fund fund balance for the creation of a new Tax Department Software purchase and installation capital project (41401300DC01). Durham County Tax Administration (DCTA), for more than 20 years, has been a using a comprehensive tax software solution based on an AS400 server. The current software lacks operating, and technology efficiencies offered through newer tax systems.

DCTA issued a RFP for Property Tax Software with an initial advertisement date of August 31, 2020, last day for questions of September 16, 2020 and a proposal due date of October 1, 2020 by 2:00pm. Six (6) proposals were submitted timely for

DCTA consideration. Two proposals emerged as leaders upon review. Tax Administration staff evaluated proposals including meeting with two NC counties that actively use each of the two top proposals. Additional details on the evaluation process are in included on the supplemental form.

After an objective scoring approach whereby, each vendor was evaluated based on criteria as outlined in the RFP, Farragut scored significantly higher overall than other bid submissions. Staff believe Farragut has the best overall system that will afford the county opportunity to capitalize on efficiencies from the updated technology. While the Farragut system itself is the most impressive of those included in this evaluation, and in addition to being a clear leader in scoring, it should be emphasized the Farragut is fully minority owned and is based in Durham County. Farragut has been a member of the Durham community, and taxpayer, for many years.

On February 8, 2021, the Board of County Commissioners approved County authorization for the Tax Administrator and County Attorney to enter into contract negotiations with Farragut.

Agenda Text:

The Board is requested to approve Budget Amendment No. 21BCC000086 appropriating \$104,125 of General Fund fund balance required to support a contract between Durham County Government and Kate's Korner and Durham Housing Authority to provide learning centers at three Durham Housing Authority (DHA) communities. ReCity Network serves as the fiscal agent for the learning centers

managed by Kate's Korner. This action was approved by the BOCC during the February 8, 2021 meeting. The budget amendment appropriates the funds to support the expense. The DHA team surveyed community parents to determine the need for additional distance learning support. Based on the survey results, 85 additional children require services. The Learning Centers serve the Hoover Road, Oxford Manor and McDougald Terrace communities. Families will benefit from their children having on-campus support for their children. In turn DHA and DPS asked Kate's Korner to be a service provider to meet these needs for the duration of the school year. ReCity Network serves as the fiscal agent for the learning centers managed by Kates Korner.

The contract supports an additional 85 students who reside in Durham Housing Authority Communities at the costs of \$175 per student per week. The rate is consistent with fees charged for youth program. The amount translates to \$35/day per student. The cost excludes overhead fees, as DHA will not charge Kate's Korner rent for the program space. The cost reflects 7 weeks of the third quarter totaling \$104,125.00. General Fund fund balance appropriation will be used to support the contract. An update will occur in March 2021 on the fourth quarter allocation.

Budget Amendment Ordinance No. 21BCC000092 Transferring \$24,000 for Continued Housing of COVID+ Homeless Individuals

Agenda Text:

The Board is requested to review and approve Budget Amendment Ordinance No. 21BCC000092 transferring \$24,000 across Functional Areas to allow for continued housing of COVID+ homeless individuals.

In April 2020, near the beginning of the COVID19 pandemic, the County began providing safer, non-congregate housing options for many homeless individuals in Durham, particularly those associated with Urban Ministries of Durham. As some in our homeless population began to test positive, and recognizing the need to limit further spread, the County (and community) realized that COVID+ homeless

individuals needed their own, safe housing options where they could safely wait out their quarantine and be provided with some of the necessary supports (food, medical checks, etc.). In early July, the County executed a contract with Bergman Rentals (DBA Southern Repair Service) for two duplexes containing 14 beds. The initial contract expired at the end of December but was extended through the end of February to allow time for a full RFP process to be conducted.

The first RFP yielded no valid proposals, so after some discussion the County opted to re-bid the opportunity, offering some technical assistance to potential bidders. Proposals were due on Feb. 16th. This new RFP yielded one valid proposal (from the same provider who has been providing the duplexes since July 2020), which the review committee reviewed on Feb. 17th. The committee recommended negotiating with the bidder, which was done and which resulted in a number of facility improvements as well as a savings to the County of approximately \$2,400 per month. Those revised terms are reflected in the attached contract. The contract runs March 1st through June 30th, the soonest that 100% FEMA reimbursement will expire. It is not to exceed \$24,000, will be housed in the Office of Emergency Services, and will be executed by the Emergency Services Director.

Funds that were set aside at the outset of FY 2020-21 Budget are being used to cover this expenditure. The remaining balance of \$18,177 is being used from the original COVID set aside funds, and an additional \$5,823 is coming from the funds that were reserved for the economic uncertainty in revenue and expenditure needs captured from the hiring freeze. The need for a Budget Amendment is due to the adoption of the Budget Ordinance at the Functional Area level and this expense is being budgeted to be paid out of the Public Safety Function.
