Good Afternoon Rachel & Team,

I have updated our list based upon your update.

I apologize if we were not clear regarding the routine services and the charges that are associated with it.

The routine service rates is made up of the Basic Grounds routine service which includes:

- Picking up the trash.( Mondays and Fridays)
- Mowing and trimming the grass. (Every two weeks)

- > Removing the leaves in the fall of each year.
- It also includes sweeping or blowing away the debris. (Mondays and Fridays)

The cost for the basic ground routine service charge is \$2,819.11. This charge is designed to cover the cost of labor for our Grounds team that comes to service the various properties.

The Pest control service is a monthly inspection. The service charge for this service is \$316.04. In this routine monthly inspection there is a pesticide application that is applied on a quarterly basis. The quarterly application last for 90 days. If an additional application is requested there will be an additional service charge (\$316.04) to cover the cost of the additional application.

Equipment usage/depreciation is not built in the monthly rate. Please keep in mind, that we only bill you as we use the equipment. If we include the equipment rates in the monthly rate, then you will be paying for rental rates for all equipment whether our grounds team use it or not.

The charges on the invoices for July 2022, August 2022 and September 2022 are billed correctly.

As it relates to the equipment rates charges, ABC has agreed to these equipment rates charges as far back as 2013. We did not err in charging ABC for equipment rates. Once again, you only pay for equipment rates when we actually use the equipment.

I think the missing element that was not brought out in the meeting is that we were using a different billing system prior to March 2021 and I believe this is the reason why it appears that on the invoice summary you were not seeing the equipment rate charges however if you look back in your historical documents the equipment rate charges were being assessed.

If you would like, I am happy to come and go over the invoices with you and your team to make sure we are all on the same page.

I hope this brings more clarity and if not please let me know. We value ABC as a customer and partner of Durham County.

I have gone thru the new scope of services for F/Y 2022/2023 I have a few things that I have notice that are wrong or need to be made very clear. First are the location that are leased verse owned and the address are not all correct either. The following chart has all off our locations and buildings that we need the services at and states if they are owned by us or leased. Also per our meeting your side stated that the basic grounds and pest control amount includes any and all equipment that was being used to perform the basic services should be already included in the rate we pay not separated out as extra charges on the invoices. The three invoices for the months of July 2022; August 2022; and September 2022 we are still being charged the for all the equipment that is being used to perform the basic services. This was something back in March of 2021 that started showing up on invoicing without anyone on our side having any clue why we all of a sudden started getting charge for equipment on our basic services for grounds. I just want it clearly stated that the equipment charges start only on services that are beyond our basic service. Will Durham County be going back and looking at all the extra equipment charges we have paid from March 2021- September 2022 invoices and correct/ credit these equipment charges back to Durham County ABC Board. I just want to know the final decision on this issue prior to us taking this agreement to our Board for final approval. Also we need the location chart cleaned up from what is currently on the Attachment 1 the county sent over.
