

### Agenda Action Form Overview

The Board is requested to review and approve the Interlocal Agreement between Durham County and the Alcohol Beverage Control (ABC) Board for maintenance services at ABC locations within Durham County.

#### **Background/Justification**

The interlocal agreement between Durham County General Services and the ABC Board is to providing maintenance services for the ABC properties. The previous Interlocal agreement required updates, and General Services is requesting to enter into a new Interlocal Agreement with an updated rate. The updated monthly rate for routine services is a 28% increase over the previous year. This increase is due to increase in employee wages and material costs associated with providing the routine monthly service. The monthly rate is a total cost of \$4,336.85 plus \$0.625 per mile. This cost breakout includes \$2,819.11 for basic grounds maintenance, \$316.04 for pest control services, and \$1,201.70 for administration services. Costs for prior fiscal year 2022, current fiscal year 2023, and projected cost for upcoming years is listed in the table below.

The monthly routine services include pickup of exterior trash and debris from all lots and grounds. Emptying exterior trash receptables and replacing trash liners. Mowing and trimming grass every two (2) weeks. Removing leaves in the fall each year. Pest control services are also provided to each location monthly. Should additional services be required for grounds, HVAC, plumbing, electrical, or building maintenance at cost service rates have been established. The ABC Board reviewed and agreed to the rates and services during their November 15, 2022, board meeting.

Approval of this Interlocal Agreement aligns with the current Boards policy of maintaining County facilities in order to provide services to the community.
