# **Agenda Action Form Overview**

Approval to Renew the County's Three-Year Microsoft Enterprise Agreement Contract for the Continuation of Microsoft Licenses and Services, and to Authorize the County Manager to Execute Subsequent Maintenance Renewals, Amendments, and Annual Payments Not to Exceed the Existing Operational Budget. The Amount of this Enterprise Agreement Contract is \$1,326,279.87.

# **Background/Justification**

The Board is requested to approve another three-year Microsoft Enterprise Agreement contract for the continuation of Microsoft licenses and services. These Microsoft licenses and services will be purchased through SHI Corp., a reseller of technology products, per the State Convenience Contract 208C. The amount of this Enterprise Agreement contract is \$1,326,279.87 and will be funded from IS&T's current fiscal year 2022-2023 operational budget.

The Board is also requested to authorize the County Manager authority to execute subsequent maintenance renewals, amendments, and annual payments not to exceed the existing operational budget if the need arises. This authority will allow the flexibility to quickly respond to time sensitive matters if needed.

The licenses and services provided by the Microsoft Enterprise Agreement allow County employees usage of critical productivity tools and applications including Office 365 while strengthening information security using several best-of-industry cybersecurity tools.

The Enterprise Agreement also provides operational systems upgrades at no additional charge which offers the opportunity to enhance user experience, utilize next generation security features and aligns Durham County with industry best practices.

The Microsoft Enterprise Agreement keeps Durham County in line with best practices across the private and government sectors as more organizations shift to cloud services. Benefits of cloud services include business continuity, access to automatic updates and more.
