Agenda Action Form Overview

Execution of Architectural Design Services contract with DTW Architects & Planners, Ltd, Durham, NC, for design and construction administration services for the renovations to the Durham County Administration Building.

Background/Justification

The project involves the renovation and backfill of the ground and first floors of the Durham County Administration Building. These floors are currently occupied by the Register of Deeds and Tax Offices, which will be relocating as part of the Judicial Building Renovation. Additionally, various other departments within the building require expansion due to service needs as many of the departments currently occupy multiple floors. The project will improve department consolidation and adjacencies along with addressing other building issues identified during the programming/evaluation phase.

Policy Impact

This project was approved during the FY 16-17 Capital Improvement Plan update (pg.3). Funding for the design and preliminary activities is available in the Administration Building Renovations project.

Procurement Background

Architects and engineers are selected using qualification-based RFQ processes as outlined in NC G.S. 143-64.31. This statute requires that State and all public subdivisions and Local Governments units thereof, except in cases of special emergency involving the health and safety of the people or their property, to announce all requirements for architectural, engineering, surveying, construction management at risk services, design-build services, and public-private partnership construction services to select firms qualified to provide such services on the basis of demonstrated competence and qualification for the type of professional services required without regard to fee other than unit price information at this stage, and thereafter to negotiate a contract for those services at a fair and reasonable fee with the best qualified firm.
