O'Brien/Atkins is pleased to present Durham County with a proposal to provide additional construction administration services for the relocation of the officer's station in each of the direct supervision housing units and for the removal of the wall between the Training Room and the Muster Room.

Scope of Project

The project encompasses replacing the officer's station in each of the 10 direct supervision housing units. This will require replacement of the existing plastic laminate stations with new concrete masonry stations built with raised access flooring, new casework, disconnection and reconnection of data, fire alarm, and door control wiring and cables. After further review of the construction process and the potential for liquidated damages, it was decided to increase the number of calendar days for the construction duration by 120 days for a total of 365 calendar days. The original construction duration was 245 calendar days, which was the basis of our current fee.

Additional scope of work also includes the removal of the metal stud and gypsum board wall between the Training Room and Muster Room in the jail and providing an accordion type movable partition in its place. This will require the design and installation of a steel beam to support the movable partition. The removal of electrical and data outlets will also be required.

Scope of Services

O'Brien/Atkins proposes to provide the construction administration services and construction documents for the wall removal and added movable partition as outlined in this proposal and defined in our Agreement with Durham County. The following services are included in this proposal:

- Additional Four Months (120 days) of Construction Administration for Relocation of Officer
- Structural Engineering for the Design of the Steel Support Beam for the Movable Partition
- Construction Documents for the Wall Removal and Provision of Movable Partition
- Revision of Specifications and IFB Document to Include the Wall Removal as an Alternate
