

# Agenda Action Form Overview

The Board is requested to approve a contract amendment in the amount of \$7,000 to provide additional funding for Freddrick's Housekeeping Service to continue performing stadium event clean up. Freddrick's Housekeeping has a standing contract with Durham County to provide janitorial services at multiple County facilities including the Memorial Stadium. Due to the fluid nature of events scheduled at the stadium, the present funding approved for janitorial services at the stadium (\$29,916.00) has been exhausted. As events are added throughout the year, the need for janitorial services is also increased. The \$29,916.00-dollar amount that was approved previously by the Board was based on historical numbers that are no longer adequate. Janitorial services are a critical part in maintaining the cleanliness and overall reputation of the facility. The additional funding will allow for growth in the stadium event schedule while maintaining a clean, welcoming environment.

## **Background/Justification**

In 2017, a janitorial contract was issued to Freddrick's Housekeeping for stadium event cleanup, which included a schedule of fees that was submitted with their bid pricing for IFB No. 15-016. Having no definite way of predicting the future event schedule for the stadium, the dollar amount budgeted was based on the prior year's expenses under a separate contract. At this point the funding budgeted for stadium janitorial services has been exceeded, and scheduled events are on the rise with the prospect of growing further. Additional funds will be needed to continue to maintain a presentable hygienic environment for the community's enjoyment.

### **Policy Impact**

Approval of this amendment fits the current Board policy of continuing to support the Durham County Memorial Stadium. This action does not require any BOCC policy changes.
