**Durham County Report
Third Quarter
Jan. 1, 2018 – Mar. 31, 2018**

- A. 30% or more of single adults will exit to permanent housing**
 - 36% (156 of 431) of all single adults exiting went to permanent housing
- B. 15% or more single adults will exit with employment income**
 - 20% (86) single adults exited with employment income.
- C. 10% or more of single adults will exit with at least one mainstream benefit**
 - 34% (146) of all single adults exited with at least one mainstream benefit
- D. The average cumulative stay for single adults will be 50 days**
 - The average cumulative stay for single adults was 32 days.
- E. 50% or more individuals in households with children exiting will exit to permanent housing**
 - 84% (37 of 44) individuals in households with children exited to permanent housing.
- F. 50% or more adults in households with children will exit with one of more sources of non-cash income (Food Stamps, SSDI, TANF etc.).**
 - 75% (12 of 16) adults in families exited with one or more sources of non-cash income.
- G. 50% or more of adults in households with children will exit with employment income.**
 - 63% (10 of 16) adults in families exited with employment income.
- H. The average length of stay for households with children will be less than 75 days**
 - 71 days was the average length of stay for households with children
- I. The number of nights of shelter provided at the Community Shelter for homeless persons**
 - 40,336 nights of shelter were provided

J. Provision of shelter for no less than 850 homeless individuals at the Community Shelter for FY

- UMD provided shelter to 644 homeless individuals, (73 in families and 571 single adults), nearly 76% of the way to the fiscal-year goal with only one-half of the year elapsed

K. The number and % of people we sheltered who had disabilities and the number and percentage who were chronically homeless.

- 20% (114 of 567) of single persons sheltered met HUD chronically homeless definition

L. Provision of quarterly demographic information consistent with universal data elements established by the Carolina Homeless Information Networks for all individuals residing at the Community Shelter, including data in average lengths of stay (for those leaving for housing), % whose last permanent residence was Durham County and % from somewhere beyond Durham County and % of individuals coming into UMD directly after being discharged from another institution.

Of the 644 guests staying in the Community Shelter this fiscal year:

- 92% (594) guests were adults
- 7% (46) guests were children
- 73% (431) adult guests were male
- 27% (162) adult guests were female
- 0% (1) were transgender
- 33% (15) child guests were male
- 67% (31) child guests were female
- 23 families were sheltered
- 9% (58) of our clients were homeless Veterans
- HMIS no longer tracks previous zip code, but we estimate that 3 of every 4 clients served had a last permanent residence in Durham County
- 9% (59) individuals came directly to UMD after being discharged from a medical or correctional institution
