THIS CONTRACT AMENDMENT is made and entered into this 1st day of July 2018 by and between the COUNTY OF DURHAM (hereinafter referred to as "County") and NIGHTHAWK SECURITY AND CONSULTING, LLC and NIGHTHAWK COMPANY POLICE, LLC, (hereinafter referred to as "Contractor").

WITNESSETH:

THAT WHERE AS, the County and Contractor entered into a contract dated August 21, 2017 for the provision of providing security services and security consulting, (hereinafter the "Original Agreement"); and

WHEREAS, the County and Contractor amended the Original Agreement (amendment #1) on 8 March 2018 increasing the contract by \$111,356.38 to \$1,730,732.88, while keeping in effect all terms and conditions of the Original Agreement not inconsistent with the terms and conditions set forth below.

NOW THEREFORE, for and in consideration for the mutual covenants and agreements made herein, the parties agree to amend the Original Agreement as follows:

- 1. The Term of the Original Agreement is hereby extended through 30 June 2019.
- **2.** The addition of the following security services for the Administration II building resulting in a cost increase of \$183,499,91:
 - (1) Company Police Officer
 - (1) Armed Security Officer
 - (2) Unarmed Security Officers
 - (1) Dispatcher
- 3. The compensation paid to Contractor shall be an amount not to exceed \$1,908,441.76.
- 4. REQUIRED PROVISIONS FOR CONTRACTS/AGREEMENTS/GRANTS UTILIZING FEDERAL FUNDS. Pursuant to the Federal Uniform Guidance Appendix II to 2 CFR Part 200, if Federal Funds are involved in this Contract/Agreement/Grant Agreement, by executing this Contract/Agreement/Grant Agreement, the Contractor/Vendor/Grantee, certifies that it agrees to and is in compliance with the provisions specified in Exhibit B Federal Uniform Guidance Contract Provisions Certification.
- **5.** By execution hereof, the person signing for Contractor below certifies that he/she has read this Contract Amendment and that he/she is duly authorized to execute this contract on behalf of the Contractor.
- **6.** Except for the changes made herein, the Original Agreement shall remain in full force and effect to the extent not inconsistent with this Amendment. In the event that there is a conflict between the Original Agreement and this Amendment, this Amendment shall control.

IN WITNESS WHEREOF, the parties have expressed their agreement to these terms by causing this Contract Amendment to be executed by their duly authorized office or agent. This Contract Amendment shall be effective as of the date herein.
