**3. Food Shuttle to open new Child food Hub:** Grand Opening to be held on September 27, 2018 DURHAM, North Carolina – Inter-Faith Food Shuttle is opening its new Child Food Hub, a 7,000 sq. ft. facility that will lead the way in fighting childhood hunger in the Greater Triangle. The Child Food Hub will be officially opened on September 27, 2018 at 10 a.m. with a dedication ceremony led by Dave Koch, President/CEO of Inter-Faith Food Shuttle, and Steve Schewel, Mayor of Durham. The new warehouse is located at 2436 S. Miami Blvd., Ste. 200-9, Durham, North Carolina 27703.

The dedication on September 27, 2018 will include tours of the new warehouse and a ribbon-cutting ceremony. It will also kick off the 2019 Band Together partnership, which has a goal of raising more than one million dollars to support the expansion of Food Shuttle child hunger programs. Tours and a light breakfast start at 10 a.m. with a ceremony following at 10:30 a.m.

**4. Art of Cool Festival 2018:** 5th Anniversary Edition on Friday, September 28, 2018. A cool remix of Black American Music takes place in downtown Durham for a weekend festival of forward-thinking Jazz, alternative Soul and mature Hip Hop. # **Proclamation - Domestic and Care Workers Day of Recognition**

Vice-Chair Hill read the following proclamation:

#### **DURHAM DOMESTIC WORKERS DAY OF RECOGNITION | 2018**

WHEREAS, domestic and care workers are the childcare, direct care providers and housecleaners who do the important work of making our homes safe environments and offer much needed care for ourselves and our loved ones; and

**WHEREAS,** domestic and care workers are the backbone of our economy and make it possible for others to work; and

**WHEREAS,** there is an increasing need to fill essential roles of caring for the projected 1 in 5 elderly individuals who will need in-home services in the future and the hundreds of thousands of children needing care; and

**WHEREAS,** domestic and care workers provide physical, medical, emotional and spiritual support for the individuals they work with; and

**WHEREAS,** historically these roles have been performed by women, Black people and people of color, undocumented individuals and other vulnerable populations, and have been invisibilized and devalued; and

**WHEREAS,** there are 3 million domestic and care workers nationwide whose contributions go unnoticed, who don't receive fair wages or benefits, who labor in unsafe conditions and are not covered by comprehensive labor protections; and

**WHEREAS,** unpaid family caregivers who provide assistance to 70 percent of aging adults and provide 72 percent of home-based child care are not recognized for the invaluable support they provide; and

WHEREAS, there is a history of domestic and care workers creating and leading social justice movements, and domestic and care workers in the South like Dorothy Bolden have organized and demanded dignity and recognition and pushed for policy and social change to honor this vital workforce; and

**NOW, THEREFORE, BE IT RESOLVED** I, Wendy Jacobs, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby recognize

# DURHAM COUNTY RESOLUTION IN SUPPORT OF A SEPARATED MULTI-USE PATH ALONG NC 98 IN DURHAM COUNTY

- **WHEREAS,** the Durham-Chapel Hill-Carrboro Metropolitan Planning Organization, along with partner municipalities, have actively worked to develop a Comprehensive Transportation Plan for the Durham-Chapel Hill-Carrboro MPO; and
- WHEREAS, the MPO and the North Carolina Department of Transportation (NCDOT) are directed by North Carolina General Statutes 136-66.2 to reach agreement for a transportation system that will serve present and anticipated travel demand in the MPO; and
- WHEREAS, it is recognized that the proper movement and variety of transportation modes within and through the MPO planning area are a highly desirable element of the plan for the orderly growth and development of the MPO; and
- WHEREAS, it is recognized that elements of the Comprehensive Transportation Plan involve coordination with other MPOs in the state for regional transportation projects, such as the North Carolina (NC) 98 Corridor; and
- WHEREAS, after full study of the NC 98 Corridor, the supporting documents presented to the public, and following a public input process that included multiple stakeholder and public workshops, several pop-up events, social media engagement, and a public hearing, the MPO Board feels it to be in the best interest of the MPO to emphasize any regional transportation corridors or projects which are pursuant to General Statutes 136-66.2; and
- **WHEREAS,** the NC 98 Corridor Plan, recommends either sidewalks and bicycle lanes or a multi-use path along the portion of the corridor within Durham County, as alternative or coexisting options, to connect nearby neighborhoods, to be designed with user safety in mind, for all ages and users, and to encourage the use of the corridor for active transportation; and
- **WHEREAS,** many public schools, neighborhood retail, a County library, and other community attractions fall along this corridor within the County and carry with them a significant amount of foot traffic; and
- WHEREAS, both of the MPO's long-range plans, the 2045 Comprehensive Transportation Plan and the 2045 Metropolitan Transportation Plan, have identified the NC 98 Corridor as a location for bicycle and pedestrian facilities; and
- **WHEREAS,** the MPO and NCDOT both have initiatives to develop transportation security and safety plans to improve transit, pedestrian, bicyclist, and highway safety in the DCHC MPO planning area,

including development of Complete Streets projects and participation in Vision Zero Durham, Safe Routes to Schools, and other pedestrian safety programs; and

WHEREAS,

Goal 3 of Durham County's Strategic Plan states that the County wants to "partner with stakeholders to prevent and address unsafe conditions, protect life and property, respond to emergencies and ensure accessible and fair justice", that addressing safety in transportation projects would fall into this domain, and that there would be an inherent desire to provide the safest forms of non-motorized transportation options for families and children through this corridor;

**NOW, THEREFORE BE IT RESOLVED,** that the Durham County Board of Commissioners supports approval of the NC 98 Corridor Report subject to the following provisions:

- 1. That a separated multi-use path along NC 98 between US 70 and the Durham County line be constructed to provide the safest, most attractive option for moving pedestrians and bicyclists within and through the NC 98 Corridor area;
- 2. That the MPO works with NCDOT to re-allocate the funds associated with construction of separate sidewalks and bike lanes in order to build a multi-use path along the NC 98 Corridor Study.

Chair Jacobs asked Kimberly Simpson, Tax Administrator to speak about the 2019 reappraisal schedule of values and the submission process. Ms. Simpson stated the statues were clear regarding the notification process. She added the advertising would begin on September 25, 2018 and the public comment period would begin October 22, 2018. Ms. Simpson continued to say the schedule of values was scheduled to be approved November 2018 and if citizens wanted to appeal they could do so after the adoption.

The Board expressed how wonderful the tax staff was with individually working with citizens to create payment plans. They also stated in the event reassessments increased in January; that does not mean higher taxes would be paid.

# **Regular Business**

#### **Announcement of "I Voted Sticker" Contest Winner**

Derek Bowens, Board of Elections Director thanked the Board and introduced all board members in attendance. Luke Farley, Chairman of the Board of Elections shared a brief presentation of all drawings submitted for the contest and announced the winner.

Mr. Farley stated the winner of the "I Voted Sticker" contest was Joshua Klein. Mr. Klein was not present, so his mother accepted the award on his behalf. Mr. Farley stated this would be a regular contest with submissions every 2-4 years.

# **Public Hearings**

#### **Unified Development Ordinance Text Amendment, FEMA FIRM Updates (TC1800003)**

Michael Stock, Senior Planner explained the purpose of the amendment was to revise the flood insurance rate map or (FIRM) panels issued by the Federal Emergency Management Agency (FEMA). He added Joint City-County Planning Committee (JCCPC) reviewed the information and had no concerns. Mr. Stock stated JCCPC recommended this item for approval at the July 10<sup>th</sup> meeting with a 12-0 vote and City Council approved this amendment at the September 4<sup>th</sup> meeting. He requested to Board consider the two motions for approval.

The Board questioned the relationship between the new and old terms. Mr. Stock stated the special hazard floodplain area was a 100-year floodplain which was made up of the floodway and the floodway fringe. After conversation about acreage expanded in the floodplains, the Board stated it was important to educate residents about the possibility of their property being added in a flood zone. Mr. Stock stated he would make sure future amendments explained those details. Commissioners asked if a resident was renting property, were they notified that they lived in a flood zone. Mr. Stock responded the property owners were responsible for notifying their tenants.

Chair Jacobs stated additional conversation was needed about this topic and hoped it could occur at a future JCCPC meeting.

Chair Jacobs opened the public hearing. No one was signed up to speak; the public hearing was closed, and a motion was requested from the Board.

#### First Motion

Commissioner Howerton moved, seconded by Commissioner Reckhow to adopt the appropriate State of Consistency pursuant to NCGS §153A-341.

The motion carried unanimously.

#### **Second Motion**

Commissioner Reckhow moved, seconded by Commissioner Howerton to adopt an ordinance amending the Unified Development Ordinance, incorporating revisions to amend Article 8, Environmental Protection.

The motion carried unanimously.
