NOW, THEREFORE, in consideration of the premises, the parties intend that the Agreement be amended as follows:

- 1. The contract dates will be updated to 11/19/2017 6/30/2021. Once the term of 11/19/2017 6/30/2018 has been invoiced, billing for the following annual terms in the contract will begin on 7/1/2018 in accordance with Exhibit A. Exhibit A is exclusive of applicable state, local, and federal taxes, which, if any, will be included in the invoice.
