

Agenda Action Form Overview

The Board is requested to authorize the County Manager to execute a service contract with Beynon Sports Surfaces Inc. in the amount of \$369,000.00 to resurface the track at Durham County Memorial Stadium.

Background/Justification

On August 6, 2018, the Board of County Commissioners transferred funds into the Pay as You Go Fund in order to create the Durham County Memorial Stadium Capital Improvement Project to support maintenance issues and renovations at Durham County Memorial Stadium. Durham Memorial Stadium is set to host the upcoming 2019 USA Track and Field Youth Outdoor National Championship from June 24th-30th 2019. A requirement from USA Track and Field is to have the track at Durham County Memorial Stadium resurfaced. The track was originally installed with the 2010 renovation of Durham County Memorial Stadium and is showing its age. Additionally, the current depth of track is 13mm and the track is required to have a depth of 15mm to comply with USA Track and Field regulations.

A request for proposals was solicited and three proposals were received. Beynon Sports Surfaces, Inc. was deemed the most qualified firm based on an evaluation committee's review. Beynon Sports Surfaces, Inc. proposal presented a well-defined process and timeline that stood out from the other submitted proposals. Beynon has emerged as the leading provider of premier polyurethane athletic surfacing for outdoor/indoor running tracks, fieldhouses and Olympic caliber running tracks in the United States today. The proposal offered a 5 year warranty, which other proposers could not offer.

Above and beyond the 2019 USATF Youth Outdoor National Championship is the opportunity to pursue other events that would utilize the improvements made to the track.

In review of the MWBE compliance for RFP 19-019 Track resurfacing at Durham County Memorial Stadium, there were no participation goals achieved on this project. Beyonn Sports Surfaces, Inc. will be utilizing their own workforce to perform this particular service on the project.
