On Tuesday, 03/05/2019, we received bids for the AV Scope of work. It was determined that Whitlock was the apparent lowest responsive, responsible bidder, and therefore, on Tuesday, 03/12/2019, Skanska-Holt, Vines, the Sextant Group, and Whitlock thoroughly reviewed the AV scope of work, and confirmed that Whitlock included all of the scope of work required for this package. Following the scope review, Whitlock confirmed that they would perform the entire scope of work for their base bid price of \$627,668, and that they would perform the entire scope of work associated with Alternates 1, 2, 3, 4, and 7c for the bid price of \$4,061, \$3,218, \$26,000, \$1,039, and \$10,000 respectively. Therefore, Whitlock's contract value would total \$671,986. This would amend our original GMP #2 amount from \$34,905,301 to \$35,577,287.

In their bid, Whitlock indicated that they would be performing the entire scope of work with internal forces, and therefore did not include any MWBE participation. However, since receiving their bid, Whitlock has indicated that they may be able to use an MWBE installer to help with their participation. Until we have confirmed this, we do not want to count on them included this participation amount. Please remember however that the majority of this scope of work and associated cost with this scope of work is related to the equipment being provided and installed, so there is limited opportunity for MWBE participation.
