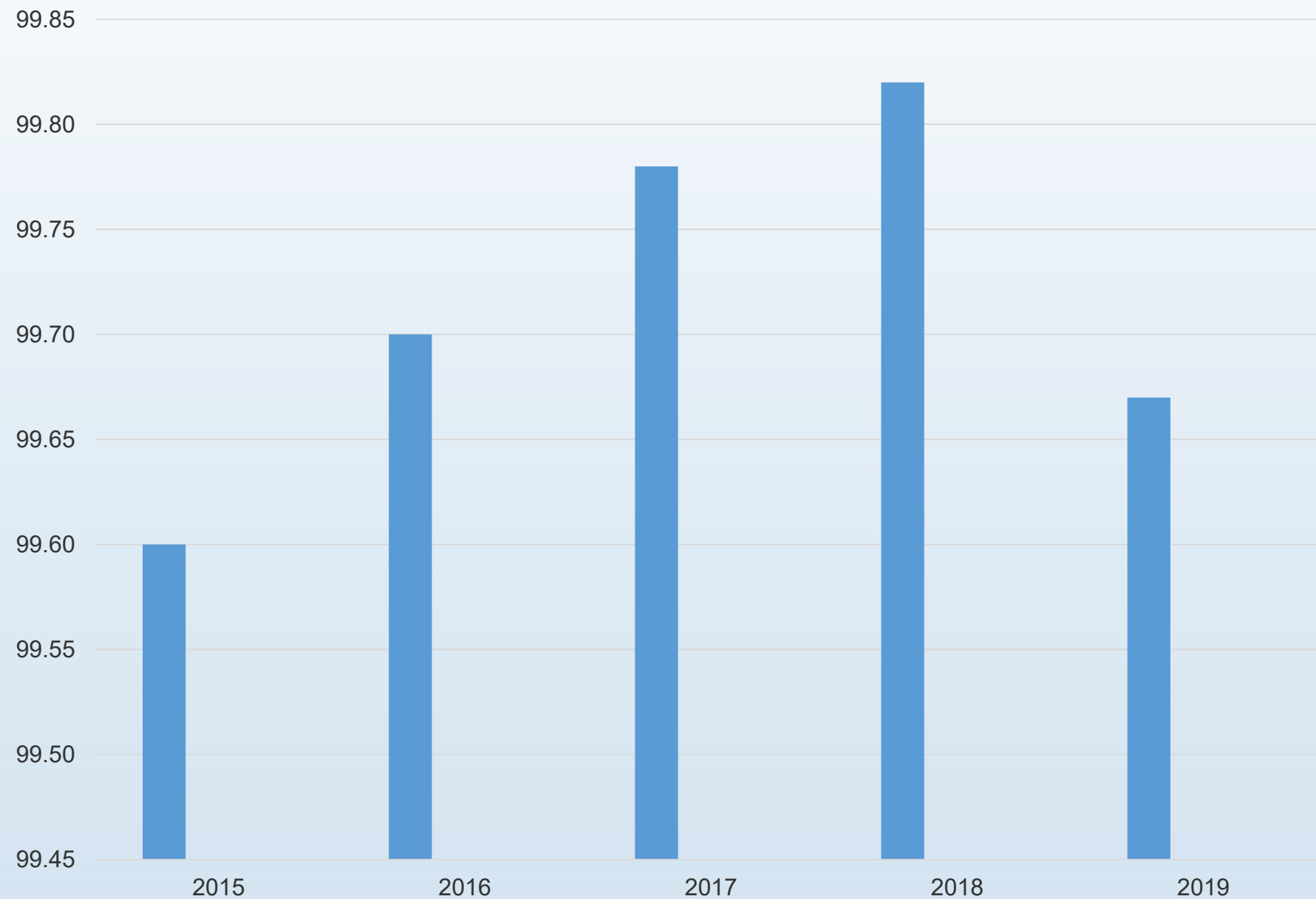


5 Year Comparison Overall Collection Rate
