TAB 2 - EXECUTIVE SUMMARY

C3 Pathways has reviewed the Scope of Services set out in RFP 19-024. C3 understands broadly the end deliverable is a comprehensive, multi-modal training program to accomplish awareness training of the Complex Coordinated Terrorist Attack (CCTA) Regional Coordination Plan and three (3) deliveries of an experiential learning course similar to TEEX PER-353 followed by a half-day Train-the-Trainer. Incorporated are planning meetings and project management to achieve identified deliverables.

The Texas A&M University's Texas Engineering Extension Service (TEEX) PER-353 course Active Shooter Incident Management (ASIM Advanced 3-day) was developed solely by C3 Pathways and is exclusively taught/delivered by C3 Pathways on behalf of TEEX and Texas State University's Advanced Law Enforcement Rapid Response Training (ALERRT).

The Active Shooter Incident Management (ASIM) series of courses were developed by C3 Pathways from the research and work being conducted by C3 to improve police, fire, and EMS response to active assailant events. This ground-breaking work led to development of the Active Shooter Incident Management Checklist, which to date has been incorporated into five (5) Department of Homeland Security (DHS) certified curricula as well as Department of Justice (DOJ) curricula and adopted by emergency response agencies in nearly every state in the US. C3 Pathways exclusively owns the copyrighted ASIM curricula and the ASIM Checklist. C3 Pathways grants **free** copyright license usage of the ASIM Checklist to emergency responders, such as police, fire, and EMS.

C3 Pathways has an in-house technology practice that develops and maintains numerous simulation and electronic learning systems used by C3 and its instructor cadre to deliver the ASIM series (such as PER-353) and other courses. C3's in-house technology practice is more than capable of developing and supporting the required 1-hr eLearning module identified in the Scope of Services.

C3 Pathways also has an in-house curriculum development group that develops and maintains all C3 curricula. The curriculum development deliverables identified in the Scope of Services are well within the capabilities of the in-house C3 curriculum team.

Finally, C3 Pathways maintains a cadre of well-trained and exceptionally skilled instructors from all disciplines within the emergency response community, including police, fire, EMS, dispatch, emergency management, bomb, SWAT, intelligence, school safety, and more.

The RFP requires three deliveries

In summary, C3 Pathways proposes delivering the following (please see full details contained within this proposal):

- Three (3) instances of:
 - the unbranded version of the TEEX PER353 course (existing 3-day ASIM Advanced course), with each delivery followed by
 - the 1-day ASIM Basic Train-the-Trainer course.
- Development of a 1-hr CCTA awareness course to include:
 - an on-line delivery format to be hosted on NCTERMS,
 - a classroom delivery format with instructor and participant guides, and
 - one (1) delivery of the classroom course.

Included within this proposal is the project management, faceto-face meetings, review, and coordination necessary to accomplish the deliverables.

This C3 Pathways proposal meets 100% of the requirements in the Durham RFP with NO exceptions taken. This proposal is submitted as a firm-fixed-priced of \$239,900.

The TEEX PER-353 ASIM course, delivered exclusively by C3 Pathways, continues to be the highest rated DHS course from TEEX, with on overall participant rating of 4.8 out of 5 (>1,600 participant evaluations, see https://www.c3pathways.com/reviews).
