Addendum 1 – CCTA EOC Training

C3 Pathways understands that Durham County is requesting an addendum to the original RFP 19-024 to provide a 2-day Complex Coordinated Terrorist Attack Emergency Operations Center training component to further enhance the Region's response and coordination through the three County EOCs. The training will be conducted in a single physical location large enough to accommodate all participants in a classroom-style seating arrangement as well as the eight (8) exercise areas illustrated below. The training will include a combination of classroom presentation and functional exercises (with hot washes) to guide participants toward a joint model for communication and collaboration in response to a Regional CCTA.

Exercise scenarios will utilize locations identified by Durham county (Kenan Stadium, Raleigh-Durham Airport, and Streets at Southpoint). Exercises will be based on the Regional Planning Project scenarios for Durham, Orange, and Wake Counties, but will allow improvisation and scenario variations.

Classroom training will present recommended practices and practical tips for achieving a coordinated Regional

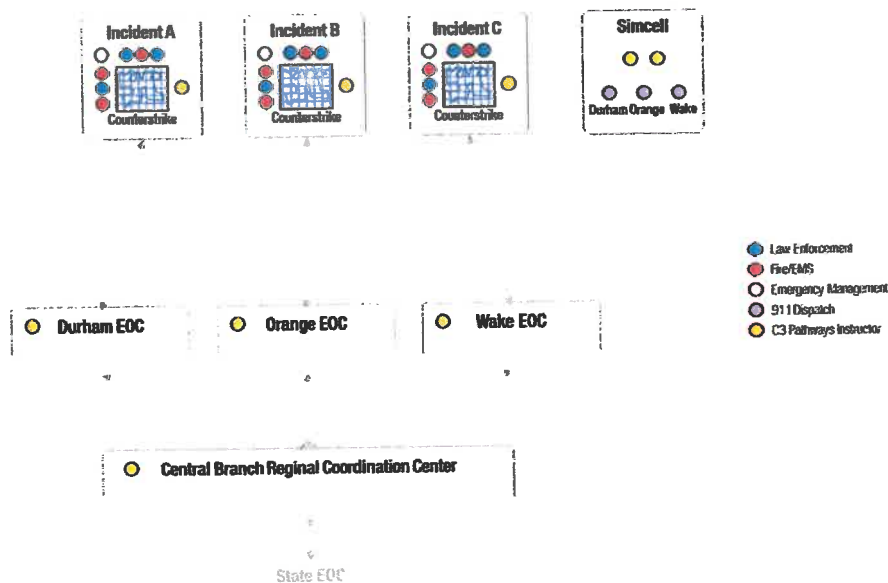
response. Participants will apply learning to exercise scenarios, discuss lessons learned, and discuss adaptations to fit local needs.

Exercise training will subdivide the 8 groups within this single training site. Incident groups will simulate each attack site of the CCTA on Counterstrike Professional Training System boards. Local resources (within the Region) are controlled by 911 Dispatchers assigned to Simcell. EOCs request resources from outside the Region through Simcell.

Exercise scenarios will utilize the requested approach of incidents communicating with their corresponding County EOC, and each County EOC passing requests to the Central Branch Regional Coordination Center for deconfliction and fulfillment.

It is desirable to utilize the existing radio infrastructure and cell phone communication during the exercises. Development of a formal Communications Plan and testing prior to the training delivery is necessary and should include alternative and backup options.
