



Agenda Action Form Overview

The Board is requested to authorize the County Manager to execute a service contract amendment with Brady Integrated Security in the amount of \$16,937.14 (for a total contract amount not to exceed \$354,831.37) for the installation of S-2 access control and video management system at Bragtown Library. On August 12, 2019 the Board authorized the County Manger to enter into a service contract with Brady Integrated Security for RFP 19-030 Security Access Control and Video Management Systems for the conversion of the existing Andover access control and DVTel Video Management Systems (VMS) to S-2 access control and VMS for various County Buildings. The current Andover Continuum system is proprietary rather than open-architecture and will be at the end of its useful life in two years.

Background/Justification

The County desires to replace its existing Andover Continuum access control system and DVTel systems, at various County Buildings, with the S-2 Netbox and S-2 NetVR. The current Andover Continuum system is proprietary rather than open-architecture and is going end-of-life in two years. The County may have future locations desiring the new S-2 access control and VMS. These future locations may or may not require the replacement of the end-of-life Andover System.

Two proposals were received for RFP 19-030 Security Access Control and Video Management Systems. Brady Integrated Security was deemed the most qualified firm for the project, based on an evaluation committee's review. An interview was held with both vendors to discuss the scope of work listed in the proposals. Brady Integrated Security either met or exceed expectations on all items listed in the scope of work. They provided a detailed approach to provide successful completion to the work outlined in RFP 19-030 Security Access Control and Video Management System.

The solicitation of RFP19-030 referenced the potential install S-2 access control for and Video Management Systems (VMS) at additional Durham County Buildings. By contracting with Brady Integrated Security camera and card reader naming conventions will be standardized and covered under warranty.

In review of the MWBE Compliance for RFP19-030 Security Access Control and Video Management Systems, there were no participation goals achieved on this project. Brady Integrated Security will be utilizing their own workforce to perform this particular service on the project.
