## WITNESSETH:

**THAT WHEREAS,** the County and Contractor entered into a contract dated June 26<sup>th</sup>, 2018, which was first amended on \_\_\_\_\_\_, 20\_\_\_\_\_ for the provision of expert assistance in expanding high quality pre-kindergarten in Durham, (hereinafter the "Original Agreements"); and

**WHEREAS**, the County and Contractor desire to amend the Original Agreements, while keeping in effect all terms and conditions of the Original Agreements not inconsistent with the terms and conditions set forth below; and

**WHEREAS,** due to an increase in enrollment and additional expenses resulting therefrom, additional funding is needed for pre-kindergarten instructional services provides in the pre-kindergarten program in Durham; and

**NOW THEREFORE**, for and in consideration for the mutual covenants and agreements made herein, the parties agree to amend the Original Agreements as follows:

- **1.** In addition to the Original Agreements CCSA shall, on behalf of Durham County, contract directly with pre-k instructional providers to provide increased services within the Durham pre-k program.
- **2.** County shall provide to CCSA an additional One Hundred Thousand Dollars (\$100, 000.00) in funding.
- **3.** By execution hereof, the person signing for Contractor below certifies that he/she has read this Contract Amendment and that he/she is duly authorized to execute this contract on behalf of the Contractor.
- 4. Except for the changes made herein, the Original Agreements shall remain in full force and effect to the extent not inconsistent with this Amendment. In the event that there is a conflict between the Original Agreement and this Amendment, this Amendment shall control.

**IN WITNESS WHEREOF**, the parties have expressed their agreement to these terms by causing this Contract Amendment to be executed by their duly authorized office or agent. This Contract Amendment shall be effective as of the date herein.
