## **Ceremonial Items**

### **Eno River Association Calendar Presentation**

Jessica Sheffield, Eno River Association Executive Director stated she came to share Season Greetings and celebrate the Boards contribution to the Eno River. She presented the Board and staff with Eno River Calendars.

The Board thanked Ms. Sheffield for the calendars and for the connection with the Eno River. Chair Jacobs explained how the Eno River was special to Durham and provided mental health for the community. Commissioner Reckhow stated she became fond of the Eno River after moving into a house in Durham on the Eno River.

### **Resolution – “Guns Down, Lives up” Rally**

Vice-Chair Hill read the following proclamation:

## **“GUNS DOWN, LIVES UP” RALLY**

**WHEREAS,** in reaction to the increasing cycle of gun violence across Durham, Southern High School football team members recently organized and conducted the “Guns Down, Lives Up” Rally to focus on ways to reduce the incidences of gun violence in the community; and

**WHEREAS,** Durham Athletes United Against Violence was formed to begin to focus attention on educating and sharing strategies to begin to break the cycle of violence; and

**WHEREAS,** a rally was held in November bringing together students, elected officials, Project Build, clergy, community members, law enforcement and others to sound the alarm that more needed to be done; and

**WHEREAS,** while the “Guns Down, Lives Up” initiative began at Southern High School, the goal is to grow the outreach to the other Durham High Schools and use a standard format to involve other athletes, students, community groups, clergy and other youth serving organizations in developing successful ways to stem the tide of violence;

**WHEREAS,** the larger goal of this group is to work to combat peer pressure, to begin with middle school students by intervention strategies and to work on prevention with high school age students.

**NOW, THEREFORE, BE IT RESOLVED,** that we, the members of the Durham Board of County Commissioners do hereby thank the founders and supporters of “Guns Down, Lives Up” initiative and encourage them to be a model for other communities to follow as they seek to reduce gun violence everywhere.

The Board congratulated Coach Robinson for organizing the rally against violence in Durham and continuing to support the Durham youth.

Darius Robinson, Southern High School Football Head Coach stated he was honored to share the initiative with the students. He added the Senior Class decided to take the first step due to peers being involved with guns and mentioned the team would visit other schools in the County to help the youth understand the importance of reducing gun violence. Coach Robinson challenged adults to get involved to provide more visibility in the community.

### **Proclamation – Together for Resilient Youth (TRY) Violence Prevention**

Chair Jacobs read the following Proclamation:

## **TOGETHER FOR RESILIENT YOUTH (TRY) VIOLENCE PREVENTION | 2019**

- WHEREAS,** Adverse Childhood Experiences (ACEs) experienced early in life can lead to a greater risk for committing violence against peers, bullying, teen dating violence and child abuse, elder abuse, intimate partner violence and sexual violence later in life; and
- WHEREAS,** children who are victims of abuse/neglect are more likely to exhibit antisocial behaviors, suffer from anxiety and depression, encounter challenges in school and abuse drugs or alcohol; and
- WHEREAS,** 28 percent of high school students reported feeling so sad or hopeless almost every day for 2 weeks or more in a row that they stopped doing usual activities; and
- WHEREAS,** 11 percent of high school students in Durham reported that they did not go to school at least once in the past month because they felt unsafe at school or going to or from school, 51 percent of high school students have seen other students being bullied and 37 percent of high school students report gang activity in school; and
- WHEREAS,** people living in low resource communities experience more crime, higher stress levels, less access to resources, higher rates of chronic disease and higher rates of early death; and
- WHEREAS,** strategies applied at the community, relationship and individual levels that include resilience as an antidote to ACEs and that address historical trauma and institutional racism can help prevent multiple forms of violence.

**NOW, THEREFORE, I,** Wendy Jacobs, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby call upon all citizens to participate in this Call to Action and join Together for Resilient Youth (TRY) in the Strive to Reduce Youth Violence Everywhere (STRYVE) initiative.

Dr. Wanda Boone, Founder of Together for Resilient Youth (TRY) explained grief was difficult to deal with and shared that some people did not know how to handle their emotions or know what to do after a violent situation. ### **Support Legislation Protecting Federal Benefits for Pre-Trail Detainees**

Dear Rep Price:

On behalf of Durham County Board of Commissioners, we urge you to support legislation that would ease the impact of the Medicaid inmate exclusion on our local justice systems. Two pieces of legislation now under consideration in the U.S. Senate, the Equity in Pre-Trial Medicaid Coverage Act (S. 2628) and the Restoring Health Benefits for Justice-Involved Individuals Act (S. 2626), take important steps toward this goal.

Currently, under what is known as the Medicaid inmate exclusion, federal law prohibits the use of federal funds and services, such as veterans' benefits, Medicaid and Children's Health Insurance Program (CHIP) benefits, for medical care provided to inmates of public institutions. However, the law makes no distinction between a convicted inmate and a person incarcerated prior to conviction, thereby denying federal benefits to individuals who are still presumed innocent under the Constitution. Additionally, because serious mental illnesses are three to four times more common among local inmates than the general population, the nation's mental health crisis is increasingly centered in our jails, with county jails among the largest behavioral health care providers in our communities.

By eliminating the Medicaid inmate exclusion and allowing federal safety-net benefits to cover pretrial detainees, these bills would promote care continuity for justice-involved individuals, decrease short-term costs to taxpayers and county governments as well as long term costs to the federal government, and break cycles of recidivism in our communities.

Detainees in Durham County Detention Center are asked about Medicaid coverage. Durham County absorbs all the medical and pharmacy costs for detainees who may require medical care/treatment. Here is just a summary of the number of inmates in this category treated over the past 5 years:

While we cannot share an estimate of the dollar amount because no names are attached to these numbers, it is clear that the numbers have significantly increased and trended upwards.

We thank you for your attention to this issue and look forward to improving outcomes for justice-involved individuals and restoring the federal, state and local partnership for safety-net programs. We respectfully ask that you consider co-sponsoring these two bills.

Commissioner Reckhow stressed the need for support; adding while attending the Stepping Up Initiative, she received a report regarding the State closing prison facilities. She stated inmates charged with major felonies remained in the County Detention Facility as opposed to being transferred to State prisons. Commissioner Reckhow requested County Manager Davis provide a weekly report on the number of inmates the County Detention Facility were housing for the State and if the County was being reimbursed by the State for housing the inmates. She explained that 13 inmates were in the County Detention Center that should have been transferred to a State prison.

Chair Jacobs thanked Ben Rose, Director of Social Services for bringing the Medicaid Inmate Exclusion Policy to the attention of the Board.

**Directive: Commissioner Reckhow requested County Manager Davis provide the Board with a weekly report on the number of inmates the County Detention Facility was housing for the State.**

**She also asked if the County was being reimbursed by the State for housing the inmates.**

Commissioner Carter asked if the 2016 bond could help finance the project. Susan Tezai, Chief Financial Officer responded staff were reviewing options for financing.
- Item 19-575 – Commissioner Howerton thanked Representative Marcia Morey for supporting and assisting with the Juvenile Justice Reinvestment Act.
- Item 19-0570 – Chair Jacobs thanked Jane Korest, Open Space and Real Estate Manager and staff for the acquisition of the easements.

Hearing no additional comments, Chair Jacobs entertained a motion for approval.

Andy Miracle, Economic Development Officer explained the Board was requested to hold a public hearing to consider allocating a total of \$950,000 in Economic Development funds to Q2 Solutions and authorize the Manager to enter into preliminary negotiations and execute an agreement with the Company. Q2 Solutions, a leading clinical trial laboratory services organization, would establish a new facility in Durham to help develop the next generation of precision medicines, creating 749 jobs and investing \$84.2 million.

Chair Jacobs opened the public hearing.

Bryan Fox, Vice President of Public Policy, Greater Durham Chamber of Commerce expressed his excitement for 749 jobs and \$84.2 million for the Durham community by Q2 Solutions.

David Efird, Attorney representing Q2 Solutions thanked Durham County for allocating the funds and

confirmed the agreement was a win for Q2 Solutions and Durham.

The Board thanked Mr. Miracle for revising the Economic Development Department and for working with companies that focused on giving back to the community. The Board inquired about how much money the State was contributing to the project. Mr. Miracle responded the State was contributing around \$10 million to the project. The Board asked how to create a pipeline to get students in school ready for jobs in the workplace. Kevin Dooley, Chief Human Resources Officer replied the company planned to work with students and teachers to allow high school students opportunities in the workplace. The Board recommended the process start as a pilot program in Durham and suggested sending a briefing letter with the company contact information to schools and Durham Technical Community College. The Board asked The Greater Durham Chamber of Commerce to provide a skillset report needed for students to enter the workplace and asked all community benefits detailed in the agenda item be incorporated into the contract.

The Board inquired about the headquarters location of Q2 Solutions. Mr. Miller responded the facility would be located at 2400 Ellis Drive in Durham; adding Q2 Solutions was located in Durham for several years and was constructing a new headquarters building.

Chair Jacobs close the public hearing.

Commissioner Reckhow moved, seconded by Commissioner Howerton for County Manager Davis to enter into preliminary negotiations and execute an agreement allocating a total of \$950,000 in Economic funds.

The motion carried unanimously

Nick Dotty, citizen stated he was concerned with the large amount of money being spent for parking decks at 300 and 500 Main Street when the County had not met the goal of reducing carbon emissions and increased the use of alternative transportation. He added several questions were sent to the Board regarding the parking decks.

The Board thanked Mr. Dotty for his concern and questions on the parking decks and explained the

issues have been a concern. They added the number of spaces were reduced and the plan was to downsize the size of the parking deck. The Board continued some of the parking deck spaces would be needed for the mixed-use space for retail, commercial, a daycare facility and some would be double used for residents, employees and overflow from the library. Peri Manns, Interim General Manager stated contracts and conversations were occurring to reduce the number of parking spaces at 500 Main Street and he was willing to meet with Mr. Dotty to answer any additional questions.

Commissioner Reckhow recommended County Manager Davis compose a letter to the Environmental Affairs Board (EAB) to review questions and issues for the 300 and 500 Main Street project. She suggested the EAB review policy changes, infrastructure changes, work schedules and other communities for best practices and provide report to Board.

Commissioner Reckhow moved, seconded by Commissioner Howerton to approve Item 19-0608.

The motion carried unanimously.


