



WHAT IS THE FY21 DURHAM TRANSIT WORK PLAN?

- July 1, 2020 June 30, 2021 (Fiscal Year 2021)
- Identifies new and continuing transit projects and services
- Allocates Durham Transit Tax revenues
- Administered by the Durham-Chapel Hill Carrboro Metropolitan Planning Organization (DCHC MPO)





WHAT TRANSIT IMPROVEMENTS ARE BEING IMPLEMENTED NOW?

- GoDurham Bus Stop Improvements
 - 19 stops constructed in FY20 so far, 11 more underway by June 30
- January 2020 GoDurham Service Expansion
 - Durham City Council approved the Short Range Transit Plan in June
 2019
 - Additional frequencies for night and weekend service
 - Route 5
 - Route 10
- Southpoint Transit Center
- Transit Emphasis Corridor (TEC) Design
- Durham Transportation Alternatives

WHAT ARE THE PROPOSED FY21 PROJECTS?



- GoDurham additional night and weekend service
- Transit Emphasis Corridors
 - Fayetteville Street
 - Holloway Street
 - Chapel Hill Street
- GoTriangle and GoDurham vehicle purchases
- Additional bus stop improvements
- Bus speed and reliability improvements
- Transportation Alternatives for Employment and Educational Centers



FY21 BUDGET

Durham County/ACCESS	391,400
City of Durham/GoDurham	17,800,850
TOTAL EXPENDITURES	\$31,601,600
PROJECTED BUDGET	\$33,500,000

Staff will continually evaluate revenues during the fiscal year and will work with transit partners to adjust expenditures if necessary.





MATERIAL CHANGES

- Bus service projects that add more than \$500,000 of cost are considered material changes
- Require adoption by all three governing boards
 - Durham BOCC
 - GoTriangle Board of Trustees
 - DCHC MPO Board

WORK PLAN TIMELINE









Staff Working Group reviews draft work plan and releases for public comment.

GoTriangle Board reviews draft work plan.

DCHCMPO Technical Committee reviews draft work plan. Durham Board of County Commissioners reviews draft work plan and considers material changes.

DCHCMPO Board reviews draft work plan and considers material changes.

Public comment period closes.

GoTriangle Board of Trustees considers FY21 work plan and material changes. Upon approval, agencies begin work to implement new projects and expanded services



DURHAM COUNTY TRANSIT PLAN

- Durham County and DCHC MPO are developing a new County Transit
 Plan to identify projects that should be undertaken with transit tax and other funds in the coming years
- DCHC MPO has recommended Kimley Horn and Associates, with Nelson Nygaard, Public Participation Partners and Pritchett Steinbeck Group, to lead the plan
- Public engagement for the Durham Transit Plan will be conducted in conjunction with the ENGAGEDurham process for the Durham Comprehensive Plan
- Staff is looking at ways to undertake public engagement with social distancing





COMMUTER RAIL

- Federal funding for Durham-Wake commuter rail is achievable
- MOU for next phase of study was approved by all parties
 - To be completed in 12-18 months
- Commuter rail specific public engagement will complement Transit Plan engagement



REQUESTED ACTIONS

- Provide input on the draft FY21 Work Plan by May 22
- Adopt the resolution approving the material changes to the Durham County Transit Plan on May 11
