Subject: 2019 Board of Adjustment Annual Report

Summary

Attached is the 2019 Annual Report for the Durham Board of Adjustment. This report highlights cases heard and acted upon by the Board from January 1, 2019, through December 31, 2019.

Recommendation

Staff recommends that the Board of County Commissioners receive the report. No action is required.

Background

The Interlocal Agreement between the City of Durham and Durham County for planning requires that the Board of Adjustment submit an annual report to both governing bodies. The attached report was prepared by the Chair of the Board in consultation with Planning staff. The board heard and disposed of 56 cases in 2019, a 60.7% increase from 2018.

Attendance

Section 2.1 of the Rules of Procedure states that Board members must attend at least 75% of the yearly meetings/hearings of the Board. In accordance with Section 2.1.a of the rules of procedure, staff will provide such notification. A copy of the attendance report has been included in this package. All but 2 members met the attendance requirements: 1 member resigned and the other member was reported to the County Clerk but no action has been taken at this time.

Subject: 2019 Board of Adjustment Annual Report

This item is the 2019 Annual Report of the Board of Adjustment, as required by the Interlocal Agreement and the Durham Board of Adjustment's Rules of Procedure. This report covers the period of January 1, 2019, through December 31, 2019.

In 2019 the Board heard and disposed of 56 cases - a 60.7% increase from the 2018 case load. The cases were distributed as follows:

- 29 minor special use permits (mSUP), which were approved;
- 1 minor special use permits (mSUP), which was denied;
- 23 variance requests, which were approved;
- 1 variance request, which was denied; and
- 2 reasonable accommodation requests were approved;

Included in this report is the attendance record for the Board members. In general, Board members were present for approximately 91.25% of board meetings.
