The Board is requested to approve Budget Amendment Ordinance No. 21BCC000023 to recognize \$15,000 in increased Medicaid Revenue and approve needed fee schedule changes for Public Health

Background/Justification

Public Health is preparing to provide Telehealth Physician appointments. During the current pandemic, healthcare organizations have been encouraged to decrease face to face office visits and provide telehealth services when available. There is a need to continue to provide services and this can be achieved with telehealth provider appointments.

Medicaid has also increased reimbursement rates. As a result, Medicaid revenue will increase (based on conservative estimates) for the fiscal year providing levels of services covered by Medicaid begin to increase as COVID-19 activity decreases.
