To receive this award at the celebration, Durham County Library Foundation must:

- (1) Sign, scan and email this letter to <u>STFoundationAdmin@SunTrust.com</u> within three business days acknowledging that Durham County Library Foundation is a registered 501(c)(3) organization and that no services or benefits were provided to the SunTrust Foundation in return for this grant.
- (2) Agree to not publicize or issue a press release announcing the Lighting the Way Award until you hear from a representative of SunTrust Bank's corporate communications team. The SunTrust Foundation is proud to award organizations like yours that are committed to instilling financial confidence, and we want to ensure you have the tools you'll need to share the news externally and with media in partnership with the foundation.
- (3) Submit a one-page annual report detailing what you achieved with the grant funds, how the grant funds were used, and how many lives were impacted. Grant reports are due by Friday, December 4, 2020, via email at STFoundationAdmin@SunTrust.com. A reminder will be sent six weeks in advance of the report due date.
- (4) Complete, scan and email the enclosed information sheet to STFoundationAdmin@SunTrust.com within three business days.
