

**AMENDMENT OF THE  
DURHAM CITY-COUNTY INTERLOCAL AGREEMENT  
REGARDING THE CITY-COUNTY YOUTH INITIATIVES MANGER POSITION**

This **AMENDMENT** entered this \_\_\_\_ day of December 2020 between the **CITY OF DURHAM**, a North Carolina municipal corporation (hereinafter "City") and the **COUNTY OF DURHAM**, a political subdivision of the State of North Carolina (hereinafter "County").

**WITNESSETH:**

**WHEREAS**, the **CITY and COUNTY** entered into an Interlocal Agreement dated August 8, 2017, to work together to jointly fund a City-County Youth Initiatives Manager, tasked with assessing, aligning, and supporting youth programs provided and supported by the City and County for youth ages 5 to 24.

**WHEREAS**, the **CITY AND COUNTY** desire to amend the Original Interlocal Agreement, while keeping in effect all terms and conditions of the Original Interlocal Agreement not inconsistent with the terms and conditions set forth below.

**NOW THEREFORE**, for and in consideration of the mutual covenants and agreements made herein, the parties agree to amend the Original Interlocal Agreement as follows:

1. The Term of the Original Interlocal Agreement shall remain effective through June 30, 2022.
2. In addition to the normal, annual amount, the **COUNTY** agrees to transfer an additional **Eighty-Eight Thousand (\$88,000.00) Dollars** to the **CITY** for uses in the Office On Youth (OOY), which is led by the Youth Initiatives Manager, as described in Section 1 of the Original Interlocal Agreement.
3. It is agreed by the parties, that the **COUNTY** shall pay the **CITY** one-third (1/3) of the total amount stated above (\$29,304) in January 2021. The remaining two-thirds (2/3) of the total amount (\$58,696) shall be paid in July 2021. Payment and the purpose of the additional funds are further described in Exhibit A attached hereto.
4. By execution hereof, the persons signing for ILA below certifies that he/she has read this Amendment and that he/she is duly authorized to execute this ILA on behalf of the respective parties.
5. Except for the changes made herein, the Original Interlocal Agreement shall remain in full force and effect to the extent not inconsistent with this Amendment. In the event that there is a conflict between the Original Interlocal Agreement and this Amendment, this Amendment shall control.

**IN WITNESS WHEREOF**, the parties have expressed their agreement to these terms by causing this Amendment to be executed by their duly authorized officer or agent. This Amendment shall be effective as of the date herein.
