Good afternoon. Below, please find some additional budget information for the HOPE Network Learning Centers. We've tried to provide a greater level of detail for our three separate organizations. Acknowledging the differences between them, it is understandable that there are variations in operating procedures (and costs), and as such, we've tried to group costs in as consistent of a way as possible.

I would like to thank you for your consideration of our request, and we remain optimistic (and hopeful) of a vote on this item this coming Monday. With DPS remaining virtual for the remainder of the school year, we are now more certain than ever that the need for the continuation of these programs is definitive. As a reminder, beyond the academic support, our programs focus on providing a safe, supportive space for some of Durham's most vulnerable children to access their remote learning. Nutritional meals for students, opportunities for parents that must work outside the home to do so, and safe and caring child care for children are just a few of the supplemental benefits of these programs. A decision on continued funding will allow us to communicate certainty and stability to our families that have come to depend on these programs.
