#### **Ceremonial Items**

# 21-0095 Durham County Proclamation to Establish A New County Holiday in Recognition of Juneteenth

Chair Howerton read the following proclamation:

#### ESTABLISH A NEW COUNTY HOLIDAY IN RECOGNITION OF JUNETEENTH | 2021

- WHEREAS, on June 22, 2020, Commissioner Brenda Howerton recommended that Durham County Government recognize Juneteenth as an official holiday for County employees honoring the historical significance of the emancipation of the last remaining enslaved Black and African Americans in the United States; and
- WHEREAS, Juneteenth commemorates the events of June 19, 1865, when Major General Gordon Granger led Union soldiers into Galveston, Texas, bringing news that the Civil War had ended and that the Emancipation Proclamation had declared all enslaved people free nearly two and a half years earlier; and
- WHEREAS, the Emancipation Proclamation changed the legal status under federal law of nearly 3.5 million enslaved Black and African Americans and the subsequent 13th Amendment of the Constitution of the United States of America abolished slavery and involuntary servitude; and
- WHEREAS, Juneteenth acknowledges the considerable lapse over a two-year period, from 1863 to 1865, when enslaved Blacks and African Americans remained in bondage and unaware of the Emancipation Proclamation issued by President Abraham Lincoln that recognized and maintained the freedom of slaves in the United States.

- WHEREAS, the celebration of Juneteenth is believed to be the oldest Black and African American holiday observance in our nation, and takes place annually throughout Durham, North Carolina and the Nation—often consisting of readings of the Emancipation Proclamation, prayer and worship services, family gatherings, cultural performances, educational activities, community service events, ceremonial observances and more; and
- WHEREAS, in 1997, during the 105th United States Congress, House Joint Resolution 56 and Senate Joint Resolution 11 were passed, officially recognizing Juneteenth Independence Day; on August 23, 2007, Juneteenth National Freedom Day was recognized by the State of North Carolina; and Juneteenth has been celebrated in Durham, North Carolina since 1933; and
- **WHEREAS,** as July 4, 1776 represents the birth of the United States of America and commemorates the United States' independence from British rule, it did not offer independence and freedom to enslaved people; and
- **WHEREAS,** historically Juneteenth observances have not always received acknowledgement and recognition though Juneteenth is a critical component of American history as it marks a turning point in our nation and a step towards equality; and
- WHEREAS, Juneteenth is a stark reminder of the promises of liberation for Black and African Americans in the 21st century; currently our nation and indeed our Durham community is experiencing racial injustices and inequities at a record pace, demonstrating that despite great successes and achievements, Black and African Americans continue to bear the pain and burden of systemic racism and disparate treatment at every turn; and
- WHEREAS, Juneteenth is also known as Emancipation Day, Freedom Day, Jubilee Day, Cel-Liberation, and Juneteenth Independence Day and Juneteenth augments the nation's promise of life, liberty, and the pursuit of happiness; and
- WHEREAS, Juneteenth commemorates the strength and resolve of Black and African Americans throughout our history and serves as an opportunity to celebrate the rich and numerous contributions of Black and African Americans to the Durham community, and the United States, and Juneteenth teaches our youth the importance of honoring Black and African American history and the impact of the institution of Chattel Slavery; and
- **WHEREAS,** Durham County seeks to establish a paid holiday for county employees commencing June 19, 2021, and forward calling them to observance; and
- **WHEREAS,** this Board of County Commissioners believes establishing an annual observance would give employees and residents of Durham County an official holiday on which to reflect on the impact of slavery, while also providing a time to remember the contributions of the enslaved to the fabric of Durham County; and
- **WHEREAS,** an official Juneteenth holiday would also signal that Durham County is committed to doing the work to identify and improve policies and processes that will improve

access to opportunities for all employees and work to eliminate any vestiges of unequal treatment that exist in this organization.

**NOW, THEREFORE, BE IT RESOLVED** I, Brenda Howerton, Chair of the Durham Board of County **Commissioners** and on behalf of the Durham Board of County Commissioners, do hereby proclaim Juneteenth to be an official Durham County Government paid holiday for employees.

**BE IT FURTHER RESOLVED** that the official observance of the Juneteenth will commence in the year 2021, which will mark the 156<sup>th</sup> commemoration of Juneteenth.

Rikii Stevenson, citizen explained the importance of Juneteenth being highlighted and recognized as a holiday in the Durham Community.

Gloria De Los Santos, Director at Action North Carolina and citizen stated she learned about Juneteenth in college and the passing of the proclamation showed the unity in Durham.

Chair Howerton thanked everyone who were involved in establishing the holiday and the proclamation. Commissioner Allam thanked Commissioner Burns for editing the proclamation and Commissioner Burns thanked the Board and the community. Commissioner Jacobs thanked staff for their support. Commissioner Carter thanked the Ms. Stevens and Ms. Santos for their comments and stated she learned about Juneteenth as an adult and hope the standards of history would be improved.

Commissioner Carter moved, seconded by Commissioner Allam to approve the proclamation establishing a New County Holiday in Recognition of Juneteenth.

The motion carried unanimously.

authorize the County Manager to enter into preliminary negotiations and execute an agreement with the Company. He added the Company specialized in Gene Therapy production and would create 202 jobs and invest \$82.8 million in Durham County.

Chair Howerton opened the public hearing.

### Angela Thedinga, Chief Technology Officer of Adverum

Ms. Thedinga provided the Board with an overview of the company, partnerships, and clients.

#### Heikki Jouttijarvi, Manufacturing and Supply Chain Vice President of Adverum

Mr. Jouttijarvi explained the hiring process, contractors, and planned buildings.

#### Dena House, Human Resources Vice President of Adverum

Ms. House shared an overview of the education, transformation, and the involvement of the company in the community.

## Bryan Fox, Vice President of Public Policy of the Greater Durham Chamber of Commerce

Mr. Fox stated he supported partnerships which addressed global health issues and would benefit all of Durham residents directly and indirectly. He added he was honored for continued increase in access and equity with opportunities across the community.

The Board stated the briefing sheet showed all jobs required a master's degree and inquired about the skill set of education for the jobs at Adverum. Ms. House clarified that jobs at Adverum would have a skill set range from no degree to a master's degree. The Board emphasized the importance and the need for the jobs and opportunities to benefit the residents of Durham. They thanked the Company Officials for providing details about the company and for supporting the community.

Chair Howerton stated the public hearing would be open for 24 hours for receipt of comments.

#### Other Business

#### 21-0025 Durham County Public Health Focused Update on the COVID-19 Crisis.

Rodney Jenkins, Public Health Director thanked the Board and County Management for their support in the COVID response.

Mr. Jenkins provided the following updates for Durham County:

- 19970 total cases
- 137 seven-day moving average
- 37.9 percent were African American; 23.3 percent were Caucasian; 19.8 percent were LatinX
- 13.3 percent of cases were under age 18
- Greatest number of cases were among people who worked in nursing care facilities, hospitals, general medicine or surgical and technical.
- North Carolina infections had grown 5.9 percent and Durham infections had grown 4.9 percent.
- Vaccination availability would increase in the coming weeks and months.

The Board asked when the Walgreen's in Durham would start vaccinations. Mr. Jenkins replied February 12, 2021. The Board inquired about the logistics for a mass vaccination site and mobile testing in Durham. Mr. Jenkins stated the mass vaccination center would be sponsored and managed by the

State and the site in Durham was on hold until an adequate supply of vaccinations was available. He added he would research mobile testing sites and follow-up with the Board.

Commissioner Burns read the following resolution:

#### SHOTS FOR A SAFE RETURN: SUPPORTING VACCINATION OF SCHOOL WORKERS

- **WHEREAS,** our public education system is among the most critical community infrastructure, providing academic instruction, social and emotional learning and support, vital childcare, nutrition, health services, and social connectedness for children and families; and
- **WHEREAS,** it is a top priority for our Durham Community that we ensure safe spaces in which our students can learn and grow, and our school staff can work; and
- **WHEREAS,** each school worker is essential to providing our students with safe, healthy learning environments; and
- **WHEREAS**, there are safety protocols recognized by the CDC for reopening schools to minimize risk posed by in-person learning for our staff, our students, and their families; and
- **WHEREAS,** Governor Roy Cooper has consistently emphasized the importance of the three Ws in creating safe learning environments: wear a mask, wait six feet away, and wash hands; and
- WHEREAS, newer, more contagious and more deadly strains of the virus have recently emerged, reinforcing the importance of the social distancing and masking requirements consistent with Governor Cooper's "plan B" guidelines; and
- **WHEREAS,** effective COVID-19 vaccines have now been developed, with more than one million doses having been distributed throughout North Carolina; and
- WHEREAS, adding vaccination of educators to the three W's would add another layer of protection from the COVID-19 virus; and
- **WHEREAS,** we value the health and safety of our staff, and believe that ensuring vaccine access for educators and all school based personnel will improve the safety of in-person instruction, and improve health outcomes overall for our students, our families, and our community.

**NOW, THEREFORE, BE IT RESOLVED,** The Durham County Board of Commissioners urges NC Secretary of Health and Human Services Mandy Cohen, along with Governor Roy Cooper, to shift school-based personnel to priority Category 2 so that they can be vaccinated in this current phase and in advance of the re-opening of schools; and

**BE IT FURTHER RESOLVED** that Durham County Government stands ready to coordinate our local health department efforts with those of NC Public Health officials, Duke Health System and other community partners to facilitate making the vaccine available to each of our school workers with all due haste so that we can reopen our vital public education system with the greatest assuredness of safety.

The Board thanked the Local Teachers Union and Durham County Public Health for working to get teachers and school staff vaccinated. The Board stated they would share the resolution with legislatures, the Governor, and local delegations.

Commissioner Carter moved, seconded by Commissioner Burns to adopt the Shots for a Safe Return: Supporting Vaccinations of School Workers Resolution.

The motion carried unanimously.

#### 21-0063 RFP 21-003 Property Tax Software Solutions

Timothy Dwane Brinson, Tax Administrator shared the *Property Tax Software Solution* presentation which highlighted the following: Needs Analysis, Request for Proposal (RFP) Number 21-003, Proposal Evaluation, Scoring, Overview of Cost – Farragut and Farragut Overview.

The Board inquired about minority participation and Minority and Women Business Enterprise (MWBE). Jeff McDonald, Local Government Solutions Vice President of Farragut Systems replied the Company was minority owned and 62 percent of the staff was minority. The Board asked about the anticipated yearly cost of the software, Mr. Brinson responded the anticipated cost was around \$300,000 per year and the actual cost would be based on the number of bills Durham County issued.

Commissioner Allam moved, seconded by Vice-Chair Jacobs to authorize the Tax Administrator and County Attorney to enter into contract negotiations with Farragut.

The motion carried unanimously.

#### 21-0078 Postpone the 2023 General Reappraisal

Timothy Dwane Brinson, Tax Administrator shared the *Postpone 2023 Reappraisal* presentation which highlighted the following: General Reappraisal Defined, Applicable State Laws, Background and Complications, Equity Measures and Request Action.

The Board inquired about vertical and horizontal equity and the abbreviation COD. Mr. Brinson responded vertical and horizontal equity was two equity measures and COD was the coefficient of dispersion. The Board asked if the reappraisal had to be postponed until 2027 or could it happen earlier. Mr. Brinson replied postponing until 2027 would allow two (2) years for the new tax software to be implemented and meet the state reappraisal standards to start the reappraisal process three (3) years

before the effective reappraisal date. County Manager Davis stated the economy and pandemic influenced the need to postpone the reappraisal. Mr. Brinson added conducting a reappraisal during a recession was regressive. The Board asked if postponing the reappraisal would allow for focus on low income and people of color. Mr. Brinson responded the Tax Department was trying to be creative as possible to finds ways to assist residents of Durham.

The Board recommended adding the Tax Assistant Program discussion to the Budget Retreat or the February 22, 2021 Regular Session meeting and, also questioned the impact of waiting to postpone the reappraisal. Mr. Brinson replied the North Carolina Department of Revenue would require work to be done by the Tax Department until the Board approved the postponement of the appraisal. The Board recommended to postpone the reappraisal until 2026. Mr. Brinson agreed with postponement of the reappraisal until 2026.

Commissioner Burns moved, seconded by Vice-Chair Jacobs for the Board to postpone the next general appraisal until January 1, 2026.

The motion carried unanimously.

Directive: Vice-Chair Jacobs recommended adding the Tax Assistant Program discussion to the Budget Retreat or the February 22, 2021 Regular Session meeting.

#### **21-0102 FY 2020-21 Fiscal Update**

Claudia Hager, General Manager shared the *Durham County Government Fiscal Update* which highlighted the following: Budget Management Reminders, Draft Projected Unbudgeted Year-end Operating Expenses as of February 8, 2021, Mid-year Salary Review, Employees Impacted by COVID-19, Hazardous/Differential Pay Options, Next Steps Fiscal Management.

The Board asked for the information requested as directives at the January 25, 2021 Regular Session meeting and community related expenses. Ms. Hager responded the information would be provided to the Board. The Board asked if the proposal for hazardous pay was for every employee or only frontline workers. County Manger Davis replied the pay was for all employees working in hazardous conditions; adding some employees resigned or took other jobs with less hazardous risk. The Board asked for a list of employees considered high risk, the percent of employees vaccinated and the cost of providing employees a merit increase. County Manger Davis replied the information would be provided to the Board. The Board recommended to continue the discission at the Budget Retreat.

#### **Directives:**

- Vice-Chair Jacobs asked for the community related expenses.
- Commissioner Carter asked for a list of employees considered high risk, percent of employees vaccinated and the cost of providing employees a merit increase.
- Chair Howerton recommended continuing the FY2020-21 Fiscal Update discussion at the Budget Retreat.

## 21-0103 Proposal for Durham County partnerships with Kate's Korner and Durham Housing Authority (DHA)

Kezia Goodwin, Owner and Founder of Kate's Korner stated her employees were excited to provide a bridge to serve an additional 85 students who resided in Durham Housing Authority Communities at the cost of \$175 per student per week. She added the cost excluded overheard fees, as DHA would not charge Kate's Korner rent for the program space; adding they were working with Durham Technical Community College to provide program space as well.

The Board inquired about the Club Boulevard location change to Oxford Manor. Ms. Goodwin responded the Club Boulevard location was being used for COVID-19 testing and the program location was moved to Oxford Manor. The Board asked about transportation for students and the Cornwallis program location. Ms. Goodwin replied she was working on providing transportation as needed; with regard to the Cornwallis location, she stated there was concern with the internet bandwidth at the location and was waiting to hear back from DHA.

The Board suggested moving forward with the approval of the \$104,125 and consider approving additional funding after Ms. Goodwin spoke with the Durham Public Schools Foundation. Ms. Goodwin replied she was seeking full funding and would ask the Foundation to fund the fourth quarter. The County agreed to move forward with the \$104,125 request and asked that Ms. Goodwin come back with any additional request after her conversation with the DPS Foundation.

Vice-Chair Jacobs moved, seconded by Commissioner Burns for Durham County Government to fund \$104,125 in a partnership with Kate's Korner and Durham Housing Authority to provide learning centers at three Durham Housing Authority communities.

The motion carried unanimously.

Commissioner Carter moved, seconded by Commissioner Allam to recess the Regular Session meeting at 10:38 p.m.
