Unified Development Ordinance Text Amendment, Tree Coverage and Landscaping Revisions (TC1800005) (45min)

Date of BOCC Meeting: October 28, 2019

Request for Board Action:

The Board is requested to conduct a public hearing and receive public comments on the *Unified Development Ordinance* Text Amendment, Tree Coverage and Landscaping Revisions (TC1800005); and

First Motion: To adopt the appropriate Statement of Consistency pursuant to NCGS §153A-341; and

Second Motion: To adopt an ordinance amending the *Unified Development Ordinance*, incorporating revisions to amend Article 4, Zoning Districts; Article 8, Environmental Protection; Article 9, Landscaping and Buffering; and Article 17, Definitions.

Summary. Text amendment TC1800005 includes amendments to landscaping, buffering, and tree coverage standards for additional buffers for residential development sites that are mass graded, to establish or retain more tree canopy, to modify requirements for street trees, and to strengthen current specimen tree requirements.
